Based on your interest and expertise, each applicant will be subsequently assigned 2 domains where you will be expected to develop a brief concept note of a study you propose to conduct. The proposed study will have to be of an experimental design, while descriptive research will be supported by the Task Force only under exceptional circumstances. Please note that the

domains assigned to you will be based on your interest, however, the recommendations from the Technical Advisory Group will be final.
