- 1. - 3. Copies of relevant contracts / orders to be

uploaded along with bid in support of having provided services during each of the Financial year.

- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

- 1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.
- 2. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.
- 3. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

i. Bidder should be recognized from the Department of Tourism, Govt. of India/ State Govt./Any other Public Institution/ Body.

- ii. The bidder should own (minimum One) or on lease sufficient vehicles of model not older than year March 2020 vehicles registered as commercial vehicles in their names or firm"s name for use as commercial vehicles. The proof of ownership or lease holding should be produced along with the qualifying bid documents.
- iii. If vehicle is not commercially registered, approved supplier, shall get the vehicle commerciall y registered within one month from the award of the work and submit the proof to O/o Direct or, ICMR NIRRCH, Parel, Mumbai -12.
- iv. The bidder shall also submit full details of the vehicles that can be assigned in their favor and shall give a clear declaration that the firm will be able to supply commercial vehicles of mode I not older than March 2020.
- v. The bidder shall have experience of minimum period of 2 years for similar supplying not less than Two commercial vehicles/cars to any Central/State Govt. organization or any large Publi c Sector Undertaking.
- vi. Insurance: The Insurance cover protecting the agency against all claims applicable under the Workm an "s Compensation Act 1948 shall be taken by the Contractor. The Contractor shall arrange necessar y insurance cover for any claim arising out of mishap, if any, that may take place. In the event of any liability/claim falling on O/o Director, ICMR NIRRCH the same shall be reimbursed /indemnified by the Contractor
- vii. Execution Time Limit: The time period as stipulated in the contract or letter of intent sh all be deemed to be essence of the contract.

#### viii. PAYMENT TERMS

Monthly bills shall be submitted in duplicate to the authority specified in contract a long with duty slips duly signed by the user.

- ix. The liability under relevant sections of Motor Vehicle Act 1968 and IPC causing death or perm anent liability developed in the vehicle supplied by the contractor, the hiring authority has no responsibility of whatsoever and will not entertain any claim in this regard under the provisio n of the law.
- x. The engagement and employment of drivers and payment of wages to them as per existing p rovisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
- xi. No subcontracting is permissible
- xii. The contractor shall assign the job of driving of hired vehicles only to qualified experienced li censed drivers and also assume full responsibility for the safety and security of the officers/ o fficials as well as essential store items while running the vehicle by ensuring safe driving. ICM R NIRRCH shall have no direct or indirect liability arising out of such negligent, rash and imp etuous driving which is an offence under section 29 of IPC and any loss caused to ICMR NIR RCH have to be suitable compensated by contractor. Drivers should have minimum 3 years o f experience of driving. They should have Vehicle Transport License for driving passenger vehicles.
- xiii. The contractor shall when called upon to do so, place at the disposal of ICMR NIRRCH such n umber of vehicles as may be required although the number of vehicles so demanded may be more than the number of vehicles he is required to supply for the purpose of execution of the contract at same rate and terms and conditions. The number of such vehicles to be supplied extra will not be more than 25% of original schedule or requirement.
- xiv. In no case a vehicle which is not registered for the commercial purpose shall be supplied to IC MR NIRRCH and taxes etc. due to on such vehicles shall be liability of the contractor.
- xv. The contractor shall sent the vehicle for periodical servicing at the cost of the contractor, ICM R NIRRCH will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes insura nce, etc. will be to the contractor's liability.
- xvi. ICMR NIRRCH reserves right to counter offer price against price quoted by the bidder.
- xvii. Regular checking of meter by the designated transport authority may be done by the contract or, and requisite certificate may be shown to ICMR NIRRCH as and when demanded.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
