Special terms and conditions-Version:1 effective from 28-07-2023 for category Flow Cytometer

- All Provisions of Drugs and Cosmetics Act, 1940 and Rules (including Medical Device Rule 2017)
  made there under as amended till date will always be applicable. This will include all notifications
  issued by Central Drugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare
  (MoHFW) and Department of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers time to time
  in this regard.
  - 2. The sellers are registered on GeM based on self-declaration of valid Drug License, product certification, test reports etc. However, buyers must check and validate the details at their end for all applicable licenses and certifications e.g., validity and authenticity/genuineness of drug license, product certification, manufacturer certification/licenses, test reports etc.
  - 3. In case of authorized resellers/distributors, it will be the legal & regulatory liability of the manufacturer to ensure that their resellers/distributors are operating in compliance with all relevant laws and regulations and are properly licensed to sell the manufacturer's products, including verifying the validity and authenticity of drug license held by them.
  - 4. The price offered by the seller/bidder shall not, in any case exceed the DPCO/NPPA controlled price or price fixed by State Government, if any. The seller must reduce the prices if there is any reduction in DPCO/NPPA ceiling price or price fixed by State Government, if any.
  - 5. Any other Terms and Conditions which is not included or at variance with the conditions specified in STC/GTC, may be added by the buyer through Additional Terms and Conditions (ATC) in the bid to ensure items are procured from authentic/validated source with appropriate and applicable quality. The above terms and conditions are in reverse order of precedence i.e. ATC shall supersede specific STC which shall supersede General Terms and Conditions ("GTC"), whenever there are any conflicting provisions.
  - 6. **Comprehensive warranty:** Comprehensive warranty shall include preventive maintenance including calibration as per technical/ service /operational manual of the manufacturer, service charges and spares. During the warranty period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee site as recommended in the manufacturer's technical/ service /operational manual, at least once in six months. warranty shall not be including the consumables. Further there will be 98% uptime warranty during warranty period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend warranty period by double the downtime period.
  - 7. **Service centres:** Details of Service outlets in India to render services for equipment to be furnished to buyer/consignees with complete address, telephone numbers, e mails etc at time of making the supplies. It shall be the responsibility of seller to ensure that authorized service centres are available to cater to the areas where supplies are made within reasonable distance from where the service calls can be handled. Details of toll-free numbers for service call and online registration of service requests also to be provided buyer/consignee at the time of supplies.
  - 8. **Source of supply:** It shall be responsibility of seller to provide Documents regarding source of equipments such as copy of Performa invoice or any other documents to establish that the products supplied are manufactured by OEM indicated and sourced from them.
  - 9. Packing and Marking: Medical equipments being very delicate and sensitive packing for the goods should be strong and durable enough to withstand transit including transhipment (if any), rough handling, open storage etc. without any damage, deterioration etc. .The size, weights and volumes of the packing cases, remoteness of the final destination of the goods, availability or otherwise of transport and handling facilities at all points during transit up to final destination,. Quality of packing, the manner of marking within & outside the packages and provision of accompanying documentation shall take into consideration the type of medical equipments being supplied. The accessories shall be suitably labelled and packed. Each of the package shall be marked on three sides with indelible paint of proper quality: indicating contract number and date, brief description of goods including quantity, Packing list reference number, country of origin of goods and any other relevant details.
  - 10. **Spare Parts:** Seller shall provide materials, information etc. pertaining to spare parts manufactured and supplied by the OEM. It shall be ensured that the required spares are available for purchase at least for 10 years from date of supplies. In case due to any reasons the production of the spare parts is discontinued sufficient advance notice should be given to the buyer/consignee before such discontinuation to provide adequate time to purchase the required spare parts etc. Further, OEM and their service centres/dealers shall carry sufficient inventories to assure ex-stock supply of consumables and spares for the equipments so that the same are available. OEM or reseller shall always accord most favoured client status to the buyer/consignee and shall give the most competitive price for spares and consumables of its machines/equipments supplied.
  - 11. **Installation, Training, Manuals:** Seller shall be responsible to carry out Installation & commissioning, Supervision and Demonstration of the goods. They shall provide required jigs and tools for assembly, minor civil works for the completion of the installation and Training of Consignee's representatives for operating and maintaining the equipment and supplying required number of operation & maintenance manual for the goods. In case the category parameters are

- specifying any requirements regarding the installations, training and manuals the same shall also be applicable.

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

### 4. Generic

**End User Certificate:** Wherever Bidders are insisting for End User Certificate from the Buyer, same shall be provided in Buyer's standard format only.

### 5. Generic

Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

#### 6. Generic

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### 7. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 8. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 9. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy

available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

#### 10. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. ### 14. Warranty

Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide AMC Service for next 5 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into an AMC agreement ( covering preventive maintenance and servicing) with the Successful Bidder / OEM after expiry of the Warranty period at rate as mentioned above and the payment for the AMC charges would be made Quarterly after rendering of the AMC Services of the relevant AMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the AMC contract when called upon by the buyer. The original Performance Security of contract will be returned only after submission and verification of AMC Performance Security for 10% of total AMC value valid up to AMC period plus 2 months (if there is no other claim). #### 15. Warranty

Warranty period of the supplied products shall be 5 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. ### 16. Warranty

### 17. Warranty

Tender Inviting Authority: This tender enquiry for procurement of 04 No. of High Dimensional Flow Cytometry Ana lyser is being invited by the Director General, Indian Council of Medical Research, Ansari Nagar, New Delhi to be sup plied at ICMR-NIOH, Ahmedabad, ICMR-NIRRCH, Mumbai, ICMR-NARI, Pune and ICMR-NICED, Kolkata.
- 2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the pe riod of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance sec urity before the deadline defined in the request for bids/request for proposals document, they will be suspended for the period of 1 year for bids/request for proposals document from being eligible to submit Bids/Proposals for contracts with ICMR.
- 3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.
- 4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm th at submits either individually or, as a member of a joint venture, more than one bid will cause all t he proposals with the firms' participation to be disqualified.
- 5. ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the DG, ICMR will be binding and final on the subject.
- 6. Inspections and Tests: ICMR or its representative shall have the right to inspect and/or to test the Goods to confir

m their conformity to the Contract specifications. Further, The Supplier may have an independent quality test conducted and the cost of such tests will be borne by the Supplier. b. Inspection of goods shall be carried out by represent ative of ICMR and they will issue an acceptance certificate.

- 7. Packing: (a) The Supplier shall provide such packing of the Goods as is required to prevent their damage or deteri oration during transit to their final destination, as indicated in the Contract. The packing shall be sufficient to withst and, without limitation, rough handling during transit and exposure to extreme temperatures, salt, and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods, final destination and the absence of heavy handling facilities at all points in transit
- (b) The packing, marking, and documentation within and outside t he packages shall comply strictly with such speci al requirements as shall be expressly provided for in the Contract, including additional requirements strictly as per Technical Specifications, and in any subsequent instructions ordered by the Procurement agency.
- (c) Packing and Marking shall be strictly as per Technical Specifications and will be inspected in terms of provisions of specifications before clearing for dispatch.
- 8. Payment: 100% payment shall be made after receipt of complete goods/Equipment in good condition, acceptance and successful installation of goods/Equipment and subject to submission of Performance Bank Guarantee. This pay ment is subject to recoveries, if any, either on account of statutory deduction/ taxes/ Liquidated Damages, if any and non-rectification of defects/ deficiencies not attended by the Supplier or otherwise. The firm is required to submit the following documents to ICMR Hqrs for payment:
- (a) Copy of Purchase Order;
- (b) Copy of Extension Order (if any);
- (c) Invoice in original showing contract number, goods description, quantity, unit price and total amount;
- (d) Installation Report in original duly signed and sealed by the authorized officer of the consignee;
- (e) Acknowledgement of Receipt of Goods issued by the consignee Institute/ Center;
- (f) Performance Bank Guarantee
- 9. Settlement of Disputes: (a) If any dispute or difference of any kind whatsoever shall arise between the Procureme nt agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to r esolve amicably such dispute or difference by mutual consultation.
- (b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation , then either the Procurement agency or the Supplier may give notice to the other party of its intention to commenc e arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may b e commenced unless such notice is given.
- (c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in acc ordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delive ry of the Goods under the Contract. In the case of a dispute or difference arising between the Purchaser/Consignee and a domestic Supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitrator appointed by Director General ICMR.
- (d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follows.
- (i) The venue of Arbitration shall be the place from where the contract is issued and the language of the arbitration proceedings and that of all councils and communications between the parties shall be English.
- (ii) The decision of the majority of arbitrators shall be final and binding upon parties.
- (iii) Settlement of disputes through pre-institution mediation and settlement in accordance with the commercial courts, commercial division and commercial appellate division of High Courts (Amendment) Act 2018, No. 28 of 2018 Chapter IIIA.
- (e) Settlement of Disputes: Notwithstanding any reference to arbitration herein, a. the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and The Procurement agency shall p ay the Supplier any monies due to the Supplier.
- 10. Consignee details (Place of Delivery, Installation, Commissioning) –ICMR-NIOH, Ahmedabad (01 No.), ICMR-NIRR CH, Mumbai (01 No.), ICMR-NARI, Pune (01 No.) and ICMR-NICED, Kolkata (01 No.).

- 11. Insurance: Unless otherwise instructed, the supplier shall make arrangements for insuring the goods against los s or damage incidental to manufacture or acquisition, transportation, storage and delivery in the following manner:
- (a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entire stores contract ed for arrival in good condition at destination. The transit risk in this respect shall be covered by the Supplier by get ting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee.
- (b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the insurance will be g ot extended by the supplier at their cost till the successful installation, testing, commissioning and handing over of t he goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the sit e to the supplier by the consignee, such extensions of the insurance will still be done by the supplier, but the insurance extension charges at actual will be reimbursed.
- (c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be insured in favour of I ndian Council of Medical Research, covering all risks basis for the goods from supplier/ manufacturer warehouse to consignee warehouse.
- 12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) inco rporated in the contract, the purchaser/consignee shall, without prejudice to other rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidity damages, calculated individ ually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc . a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subject to a maxim um of 10% of the contract price. Once the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier.
- 13. GST will be applicable as per the latest GoI notification.
- 14. Delivery of Equipment means Supply, Installation, Testing and Commissioning of Equipment.
- 15. Following categories of Sellers are exempted from Years of Experience and Turnover:
- (a) Micro and Small Enterprises who are manufacturer of the Primary Product Category and give specific confirmation to this effect at the time of bid submission and whose credentials are validated online through Udyam Registration / Udyog Aadhaar (as validated by Government from time to time) and through uploaded supporting documents.
- (b) Start-ups as recognized by Department of Industrial Policy and Promotion (DIPP).
- 16. The manufacturer's authorisation must be insisted upon on a tender specific basis, not general authorisation/ de alership, by so declaring in the bid documents clearly. In cases where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered. In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enguiry. One manufacturer can also authorise only one agent/dealer.

#### 17. It is mandatory for the bidders to comply the following parameters of specification:

- 1. System should be a bench top and compact footprint spectral flowcytometry system equipped with 45, or more flu orescence detection channels covering entire spectral range in each laser, in addition to FSC and SSC.
- 2. System must include 5 spatially separated, solid state lasers of the specified requirements as below:
- (a) 350±5 nm UV
- (b) 405±5 nm violet
- (c) 488±5 nm blue
- (d) 561±5 nm yellow green
- (e) 635±10 nm red
- 3. System should have the capacity to record emission spectra of the excited fluorochromes ranging from 365-800 n m, or more using PMT, or APD detectors.
- 4. All the fluorescence detector channels, and side scatter channel must be designed with PMT, or APD for achieving best resolution for dimly stained and rare population, even in high complexity panels and at high flow rates without significant signal loss.
- 5. System should also have higher digital signal processing and autofluorescence extraction ability.

- 6. No optical filter changes should be required for any fluorophore excited by the on-board lasers for quick and easy setup of different applications.
- 7. System should have state-of-the art optics and mechanisms to reduce electronic noise to improve resolution.
- 8. System should have quick proportional adjustment of all detector gains/voltages and pre-optimized detector settings avoiding time consuming adjustments of individual detector.
- 9. System should have suitable cuvette for optimum transmission of laser light, collection efficiency, etc.
- 10. System should have demonstrated capability to perform analysis with 35, or more colours simultaneouslyncluding fluorochromes/dye combinations even with high amounts of overlapping emission spectra across all lasers to clearly resolve the combinations, e.g., BFP and GFP; Pacific Blue and BV421APC and Alexa Fluor 647, etc.
- 11. System should have ability to run samples at low, medium, and high flow rate with similar performance at high s ample flow rates.
- 12. System should have provision for manual tube loading up to 5 ml with sample carryover <1%.
- 13. System should be upgradable for high throughput sampling to run standard well plates/deep well plates, etc.
- 14. System should run with most of the commercially available sheath fluids for flow cytometry, or double distilled w ater, or milliQ water, etc. as recommended by the manufacturer.
- 15. System should have at least 25000 events/sec data acquisition rate with continuously adjustable flow rate.
- 16. Starter kit and reagents with QC beads, etc. should be provided to initial running of the equipment during install ation.
- 17. Vendor should be capable of providing optimal panel design support for the provided machine, which must inclu de documentary proof of utilization of such panels.
- 18. System software should have following features:
- (a) Easy experiment setup, sample acquisition, data analysis and automated QC module.
- (b) User customizable options for plots, gates, and statistics and administrative controls.
- (c) Ability to visualize autofluorescence within samples (e.g., tumour biopsy tissues, cell lines, fixed and permeabiliz ed samples, biological fluids, etc.) as a parameter and subtract it, allowing greater visualization of dimly stained population.
- (d) Ability to analyse data, using unmixing algorithm, or using virtual filters as a standard cytometer.
- (e) Capability for spectral overlap correction in real-time and also post-acquisition.
- (f) Ability to export experiment files and analyze data using third party analysis software.
- (g) Additional 2 instrument software should be included.
- (h) Output data file should be in FCS 3.0, or above format.
- 19. System should be provided with a third party offline data analysis software for basic data analysis and high dime nsional data analysis (for e.g., dimensionality reduction, statistical differential analysis, trajectory interference, norm alization, etc.) through algorithms capable of T-SNE analysis, FlowSOM, SPADe, UMAP, etc. Software demonstration must be shown during evaluation for above features. Additional licences for 3 users (for data analysis) should be quo ted.
- 20. System must be accompanied with compatible workstation from source with essential and advanced specifications, and software for data analysis. Additional workstation for off-line analysis must be provided as per specification mentioned in #21.
- 21. PC workstation specifications: Specification for additional offline workstation with analysis software including st andard data analysis, cell ploidy analysis, cell proliferation analysis, cell cycle analysis, membrane potential analysis, etc.

- 22. System should be accompanied with (i) one 3 KVA, or more online UPS with 1 hr battery backup at fulbad and maintenance free battery; and (ii) one AC of 2 ton capacity.
- 23. System should be accompanied with (i) a suitable anti-vibration, acid-proof table platform with granite top (telep hone black) of appropriate dimension for mounting of the equipment with ease along with provision of cabinets and drawers for consumable storage; and (ii) two revolving rust proof chairs with provision of adjustable height (dimensi on: seat width 18"/ height 32", or better).
- 24. Vendor should have application, training and support teams based in India for optimizing the flow-based assays.
- 25. Vendor's application and service team should be capable of directly providing complete bioinformatics/ offline d ata analysis software support.
- 26. Vender should be able to provide multiple installation references in India, or globally for the quoted instrument.
- 27. Warranty should cover equipment including all accessories (PC/workstation, UPS, AC, third party software, etc.) as mentioned above, according to ICMR tender norms.
