- 8. Each payment will be subject to Tax Deduction at Source (TDS) at the rate applicable from time to time.
- 9. ICMR NIRRCH will not provide any transportation and accommodation for the Engineers / representatives for attending services and have to make their own arrangements.
- 10. The contract may be terminated at any time by either party provided reasonable justification given in writing with 03 months prior notice. However in case of

non-compliance of terms and conditions, the contract may be terminated by the Director without any notice.

- 11. Any dispute arising out of this contract will be settled amicably between the parties.
- 12. All disputes are subject to the exclusive jurisdiction of competent court / forum in Mumbai, India only
- 13. No other condition of the firm is acceptable
- 14. The agency will be responsible for the safety of personal deployment by them for work of the site. In case of any accident/incident which may involve any injury or loss of life to the personal deployed by the agency, ICMR-NIRRCH is no way shall be responsible for such happenings and will not be liable for any type of compensation to any party. Safety of personnel deputed will be whole responsibility of the concern agency.
- 15. Contractor shall take all necessary steps to maintain the equipment (under the contract) in proper operating condition. Contractor shall use trained and appropriately supervised personal to perform the Maintenance Services.
- 16. All parts and components fitted by contractor will be original parts or components. If original parts or components are not available, the parts or components fitted will be of equal quality and functionality of reputed brands/makes with ISI mark only, after approval of ICMR-NIRRCH.
- 17. Contractor will keep sufficient Nos. of spares required for replacement during day to day maintenance and Breakdown /Corrective Maintenance to avoid delay.
- 18. The contractor shall provide Quarterly reports on the condition of the equipment in an agreed format. Records of each routine visits and call out visits, together with details of the work done or action done or action taken, shall be entered on a log book which shall be provided by the Contractor and retained in the location as decided by the Employer's Representative.
- 19. If the contractor makes any damages to any DG Set or the property of the Institute, during
- 20. The execution of the work will be recovered by the contractor.

SCHEDULE OF WORK

A. WEEKLY CHECK of DG Set:

- a. Cleaning of dust from DG Sets
- b. Clean the Radiator and FAN

- c. Check the oil level
- d. Clean the entire Air filters, 'V' belt tension, bearings, and strainers.
- e. Leak test of rectification.
- f. Checking of all electrical connections.
- g. Check the DG sets, accessories, and required parameters.
- h. Check all the control devices, safety devices, etc.
- i. Recording of fuel consumption average in a register.

B. MONTHLY CHECK of DG Set:

- a. Lubrication of all the bearings.
- b. Cleaning of all the electrical contacts.
- c. Check and adjust all the controls.
- d. Check and repair all the seals.
- e. Check and tighten the C.T. fan nut-bolts.
- f. Check all electrical connections/ground connections.
- g. Check and repair for any abnormal noise in the system.
- h. Check the electric control panel, power switches, and accessories.

C. QUARTERLY CHECK of DG Set:

- a. Checking of bearing and rectification.
- b. Tightening of foundation bolts of the entire equipment.
- c. De-scaling of Radiator if required.
- d. Checking of entire electrical panels and fault rectifications.
- e. Checking of DG Sets and associated controls.

D. D. HALFY EARLY COMPLETE SERVICE of DG Sets:

All DG Sets should be serviced complete with associated controls twice a year.
