- 1. Scope of work for Annual Maintenance Service Contract (AMSC) of DNA Analyzer 3730XL of the ICMR-NIRRCH

- 1. AMC include the labour charges. Spare required will be charged as actual.
- 2. Two PM visits in one year and ALL breakdown calls. On all days includes bank holidays and weekends also.
- 3. Service call to be attended on the same day when call is registered.
- 4. Technical support on site as well as online/on phone.
- 5. PM preventive maintenance includes lubrication, periodic maintenance activities, tuning and calibration, functionality checks and filters cleaning all the activities related to satisfactory performance of equipment.
- 6. Nonfunctional parts to be replaced with new genuine/Original parts. The defective parts can be picked up by AMC holder company arranging for transport cost/packing etc.
- 7. Consultation or training to assist customers development/Analysis of software, protocols to be provided by AMC holder company Engineer.
