2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

The Pay slip should clearly indicate the ESI number, UAN Number, Designation of the concerned staff, Number of working days and the salary breakup of employee clearly indicate ting Gross Salary, Net Salary along with clear break up of PF, ESI contribution of both Employer and Employee. No other deductions should be made out of the salary of the employee. Bank statement indicating payment made to individual manpower to be provided along with h each invoice.

6. The contractor shall pay salary to the employees on or before $\frac{1}{2}$ of following month and raise invoice to buyer (ICMR-NIRT) immediately after releasing the payment to manpo wer.

7. EPF contribution is to paid by the contractor up to the maximum wage ceiling of Rs.15 ,000/-.

8. The monthly wages to the manpower will be paid based on the number of days worke d by them in that particular month.

9. No person shall leave the assigned position, without prior approval of his/her Reportin g Authority/ Head of Institute.

10. In the event of leave without prior permission of Reporting Authority and/or any willful unauthorized absence, the concerned candidate holding the position will not be permitted t o resume duty without prior permission of Head of the Institute.

11. Service Provider will be responsible for any administrative issues of the candidate and not the institute.

12. The incumbents selected will have no claim for regular appointments under NIRT-ICMR or continuation of his/her services in any other contract.

13. The bidder should submit their willingness/ undertaking for all the terms and conditions mentioned in the bidding document under technical Evaluation Documents in GeM portal.

14. The Bidders offer is liable to be rejected if they don't upload any of certificates / docum ents sought in the bid document, ATC and corrigendum, if any.

16. Any dispute arising out of the terms of this contract or the interpretation of any clause herein shall be settled by mutual discussion between the ICMR-NIRT authorities and agenc y / contractor.

17. No payment shall be made in advance nor any loan from any bank or financial instituti on recommended on the basis of the order of award of work.

18. The contract will be awarded initially for a period of one year and based on the satisfac tory services it can be extended for further period as per the decision of the Competent Aut hority. All the rights to extend or reduce the period of contract or termination of the contra ct will be at the discretion/jurisdiction of the Director, ICMR-NIRT, Chennai and will be bindi ng on the agency.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
