1. The office of the service provider must be located in consignee location (Tamil Nadu) and doc umentary proof in this regard must be submitted for at least 6 months prior to the date of floating of the bid and copy of the same should be enclosed in the GeM portal.

2. The Service Provider should submit Registration/ incorporation certificate issued by Registrar under Companies Act.

3. The Service provider must submit statutory certificates of registration for EPF, ESIC and GST i n GeM Technical specification documents.

5. Service Provider should verify all the credentials of the candidates before sending for intervie w/selection.

6. 15. The engagement can be terminated during the tenure at any time by giving one month notice on either side. It can be terminated forthwith by the office or before expiry of the notice period by making payment of a sum equivalent to one month project position remuneration. However, the c andidate will not be permitted to surrender one month remuneration in lieu of the period of notice of unexpired portion thereof and he/she will be required to serve the full period of notice. 16. 19. On termination of the contract, they shall not be entitled to any terminal benefits including en cashment of un-availed portion of leave.

20. No deduction towards ESI, EPF should be made from the salary of the candidate. Candidates s hould be paid full consolidated salary as mentioned in the advertisement.

21. GST/service charges will be paid separately to the service provider.

22.
