- 2. The tender not submitted as per the above prescribed manner will be treated as invalid. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
- 3. The tender not submitted as per the above prescribed manner will be treated as invalid. Late/delayed Tenders shall not be considered under any circumstances.
