TECHNICAL SPECIFICATIONS:

- The instrument should be an open system for assay kits, able to accommodate kit from other manufacturers.
- Instrument should be compatible for loading 96 samples.
- The principle should be on magnetic bead based, to purify nucleic acids, proteins, cells, bacteria in a convenient, rapid and reproducible manner from different starting materials with high quality and yield.
- The processing volume should be flexible for all type of sample volumes from 30ul 5000ul (microliter).
- Entire RNA extraction time on instrument should be <40 min for samples per run.
- Instrument should not have liquid transfer step involved to avoid sample cross contaminations.
- The instrument should have an option of stand-alone mode and PC controlled mode.
- The system should have a memory for 200 internal protocols in stand-alone mode.
- The instrument should have an option of heating and cooling, for sample from +10°C to +75°C in RT and for elution strip from +4°C to +75°C in RT.
- Decontamination feature with UV lamp option with UV exposure time maximum upto 10-16 hours.
- Easy protocol import / export option using USB stick.
- The software and computer should be supplied with the instrument and the software should not have licenses key for unlimited users' access.

- Tenders (Single Bid) should reach ICMR-National Institute for Research in Reproductive Health (ICMR-NIRRH), Jehangir Merwanji Street, Parel, Mumbai 400012, Maharashtra before the prescribed date and time mentioned in the Tender. In case hard copy cannot be issued, soft copy may be mailed to <u>stores@nirrh.res.in</u> / <u>nirrhequip@gmail.com</u>.
- 2. The tender not submitted as per the above prescribed manner will be treated as invalid. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances. The quotation must be in the format furnished by Procuring Entity and should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not, the quotation will not be considered. Quotation written in pencil will not be considered.
- 3. Tender should be accompanied by "Bid Security Declaration" wherein the participating agency should undertake 'That if they withdraw or modify their bids during period of validity etc., they will be suspended for the time, as may be decided by the competent authority of the ICMR-NIRRH from its future tenders'.
- The last date for receipt of tenders in ICMR-NIRRH is 12th May, 2021 up to 17.00 hrs. Tender will be verified at 11.00 hrs. on 13th May, 2021. The requirement is for Covid-19 Facility and hence short tender period.
- 5. The equipment / instrument / system must come with inbuilt 3 years' comprehensive warranty and 2 years' non-comprehensive warranty at no extra cost.
- 6. The reasonable Annual Maintenance Service Charges (**both Comprehensive and Non-Comprehensive**) after the end of 5 years of warranty must be fixed / indicated in the bid separately.
- 7. The maximum response time during the warranty would be 48 hrs. 0.1% of Basic Cost as penalty per week till the warranty would be applicable.
- 8. The Director, ICMR-NIRRH, reserves the right to call for break-up of the quotation if it is found necessary. Incomplete specifications offered by the tenderer(s) will not be considered and are liable to be rejected.
- 9. Participation in this tender is by invitation only and is limited to the selected Procuring Entity's registered suppliers. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of Procuring Entity and apply for registration as per procedure of Govt. of India.
