- 3. Dr. Ravinder Singh apprised the committee that M/o of Defence had framed a relative merit points and revised procedure for selection for appointment on compassionate ground in 2018 and submitted a copy of the same (downloaded from the website of Defence Ministry).

4. After going through the guidelines/instruction issued by DoPT, in the matter of Compassionate appointment and the criteria followed by the earlier committee, the committee felt that the criteria followed by the Ministry of Defence(with some minor changes in the parameter is more effective in comparison of the criteria framed by ICMR.
