Candidates are therefore advised to submit their application well in time along with the application form, CV and self-attested documents.

Candidature of successful candidates shall be subject to verification of all original documents by ICMR and fulfillment of required eligibility criteria, in all respects of qualification, age and experience, etc. Successful candidates will be informed through email about interview.

## Terms and conditions:-

- 1. These positions are meant for temporary projects, for appointment purely on temporary contract basis.
- 2. Age relaxation will be admissible in respect of SC/ST/OBC candidates, retrenched Government Employees, Departmental Candidates (including projects) and Exservicemen etc. in accordance with the instructions issued by the Central Government/DoPT/ICMR from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. SC/ST/OBC will be given age relaxation in respect of the posts reserved for them only and not for UR posts.
- 3. Cut-off date for age limit will be as on the last date for submission of applications.
- 4. OBC category candidates must produce their latest Caste Validity Certificate. They must possess a latest non-creamy layer certificate, issued within three years. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
- 5. Engagement of successful candidates on the project shall also be decided by the appointing authority at its discretion.
- 6. Qualification & experience should be in relevant discipline/field/trade and from an accredited/ reputed Institution. Experience should have been gained after acquiring the minimum essential qualification.
- 7. No TA/DA shall be paid, and candidates shall have to arrange for their transport/accommodation themselves.
