Applications received within the stipulated date, time and complete in all respects will only be screened by the screening committee of NIMR to shortlist candidates for further process of engaging the above scientific project human resource positions. Candidature of successful candidates shall be subject to verification of all original documents by NIMR and fulfillment of required eligibility criteria in all respects of qualification, age and experience, etc.

## PROCEDURE FOR RECRUITMENT:

- 1. The shortlisted candidates will be informed about the interview via e-mail or candidates may check our website for updates related to the advertisement.
- 2. Shortlisting of candidates for interview shall be done on basis of educational qualification and experience. However, if the number of shortlisted candidates are high and it is not feasible to call all of them, the appointing authority may fix suitable criteria for shortlisting the candidates.
- 3. Selection of Candidate will be based on the performance in the interview.
- 4. Candidates have to submit the duly self-attested copies of proof of their age, educational qualifications, experiences, testimonials etc. at the time of joining, if selected.

PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.

- 9. Qualification & experience should be in relevant discipline / field and from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
