 Or Paediatrics/ DNB (Field Epidemiology)/ DNB (Community Medicine) / DNB
 (Epidemiology) / Master Degree in Epidemiology or Public Health / Ph.D (Epidemiology / Public Health) from a recognized University
- (i) Two years Teaching/Research experience in Epidemiology/Public Health after obtaining essential qualification.
- (ii) Knowledge of Computer Applications.

Category:

Candidates should apply with Economically Weaker Sections (EWSs) certificate

Age Limit:

Not exceeding 35 years. Relaxable upto 5 years for Govt. Servants.

Job Requirement:

The incumbent is required to plan and carry out clinical / Epidemiological studies, do statistical analysis, prepare reports and suggest prevention and control strategies for public health problems. He / She will also be a faculty member in various training courses and programmes conducted by the Institute.

Other Service Conditions:

- (1) Level-10 of Pay Matrix under VII CPC [Pre-revised Pay Band (PB-3)Rs.15600-39100 + Grade Pay Rs.5400/-] plus NPA.
- (2) Allowances as per Central Government Rules are admissible on the above pay Scale.
- (3) Benefits of new restructured defined contributory Pension system are admissible as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB & PR Division), Notification No.5/7/2003-ECB & PR dated 22.12.2003 effective from 1.1.2004.
- (4) Applications from employees working in Central/State Govt. Departments/Public Sector Undertakings and Govt. Funded research agencies must be forwarded through proper channel. How to apply:

- (2) Application forms duly completed in all respects and signed by the applicant should be sent to the Director, ICMR-National Institute of Epidemiology, R-127, 3rd Avenue, Tamil Nadu Housing Board, Ayapakkam, Chennai-600 077 on or before the closing date.
- (3) Documents to be enclosed with the application form (self attested copies):
 - a) Proof of Date of Birth
 - b) Educational qualification
 - c) Economically Weaker Sections Certificate
 - d) Experience
 - e) List of Publications with impact factor for each publication.
 - f) Demand Draft for Rs.500/- (Rupees Five hundred only) payable to The Director, National Institute of Epidemiology, Chennai. Women candidates are exempted from the application fee. DDs are payable by all other candidates including ICMR employees. Indian Scientists working abroad are exempted from application fee.
- (4) Unsigned/Incomplete application, application without required supportive evidence, applications without Demand Draft and applications received late shall be summarily rejected.

Note:

- 1) M.D./DNB/ Ph. D in relevant subjects shall be treated equivalent to 3 years experience & Master Degree in Epidemiology or Public Health shall be treated equivalent to 2 years experience.
- 2) Candidates with MD or Ph D degree will be preferred for direct recruitment

General:

- 1) Candidates called for written test / personal discussion will be paid 2^{nd} class rail fare by the shortest route on production of documents. Local transportation charges shall however be borne by the candidates themselves.
- 2) Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/recruitment shall be disqualification.
