Specification

- 1. Analytical parameters: The system must use colorimetric technology for identification and susceptibility testing of bacterial isolates.
- 2. Panel capacity: The system must have the capacity to accommodate a maximum of 60 tests (either for identification and/or antimicrobial susceptibility testing) at any one time.
- 3. Type of panels: It should have different panels. (ID & AST separately depending on the user to save cost)
- 4. Panels: Gram-negative panels, Gram-positive panels, Anaerobic ID panels, extended-spectrum beta-lactamase confirmation panels, Neisseria & Haemophilus ID panels, and yeast panels.
- 5. Testing base: Should be on a disposable sealed bar-coded card (ready to use) with pre-filled reagents with a pre-inserted transfer tube for easy automatic transfer of inoculums.
- 6. Database: The System should have database more than 2000 reference phenotypes.
- 7. Testing time: Ideally, be on the same day (between average mean time ranged between 3 -10 hrs.),
- 8. Incubator: On-board incubation chamber.
- 9. Sample dispensing: The system should not require any manual dispensing of inoculum to avoid human error, it should be done automatically.
- 10. External desktop/laptop system with software for analysis and report generation, handheld barcode scanner to handle the routine workflow with laser printer for direct report printouts should be provided.
- 11. Accessories: Pipette sets, liquid dispenser, densitometer, and all accessories required for routine operation should be provided.
- 12. Performance certificates of Installation Qualification, Operational Qualification, and Performance Qualification certificates to be submitted at the time of installation/commissioning.
- 13. 3 years warranty and post 2 years AMC.
- 14. 220-240 VAC with 50Hz and standard make UPS with 30 min backup facility to be provided.
