- 4. Calibration should be done at ICMR-NIRT, Vellore unit only.
- 5. The bidders should quote all 1-8 nos. of equipment for calibration.
- 6. Valid contact Numbers and address should be mentioned in letter head.
- 7. Interested bidders should submit GST Certificate while submitting bid in GeM portal
- 8. Bidder should sign and put company seal on the compliance sheet and same to be uploaded in Ge m Portal.
