- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. - 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
- 8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Buyer Added text based ATC clauses

- 1. The Security Agency must ensure the provisions of Private Security Agency Central Model Rules 2020 no tified by Ministry of Home Affairs, Gol dated 15.12.2020. The bidder should have Private Security Agency R egulation Act (PSARA), license of Bhopal, M.P.
- 2. The Contractor shall not engage any sub-contractor or transfer the contract to any other person/party.
- 3. The assessed number of security personnel required to be engaged will be 18 Security Guards. However, the Director, ICMR-NIREH shall have the right for increasing/decreasing the same, at his discretio n.
- 4. Police clearance regarding verification of character & antecedents of persons deployed will be obtained/produced by the contractor before deployment of such personnel.
- 5. The bio-data together with colour recent photographs of all security persons proposed to be deployed sh ould be furnished to the institute at the time of acceptance of the contract award.
- 6. A copy of the original acquaintance rolls for payment of wages may be furnished by the Contractor alon g with succeeding month's bills.

- 7. The security deposit shall be returnable to the agency after expiry of the contract on furnishing usual clearance/no demand certificate.
- 8. In case, the Contractor fails to execute the job OR leave the job before completion of the period of contract at their own, the Director, ICMR-NIREH shall have right to forfeit the security deposit.
- 9. The contract can be terminated by giving one month's notice by ICMR-NIREH and two month's notice by the agency.
- 10. In case of any loss or theft, it shall be made good by the Contractor. In the event of failure on their part to do so within a period of one month, the loss shall be made good by encashment of security deposit. If t he amount of loss or damage exceeds the amount of security deposit, then the balance amount shall be re covered straightway from the dues payable to the Contractor.
- 11. The Contractor shall comply with relevant provisions under the Labour Laws of State/Central Govt. and the institute shall not be responsible for any default/violation of the same on the part of the Contractor.
- 12. The office/ branch/ site office of the service provider should be located in Bhopal, MP.
- 13. The successful bidder shall furnish the performance security for an amount equal to 5% of bid amount in terms of Bank guarantee of any nationalized bank within 15 calendar days from the date of acceptance e of the bid which should be valid up to 14 months from the date of issue of BG. The bidder has to extend the validity of the BG up to the extended period also at his own cost.
- 14. Payment Condition:
- (a) The cost of services quoted by the Service Provider shall be cover all aspects of service delivery and in clude all the components of salary/ wages (minimum wage, insurance, PF, ESI, etc) bonus, uniform, as applicable.
- (b) The Payment shall be made as per the financial quotes submitted by the Service Provider and accepte d d by the Buyer.
- 15. Payment Cycle: (a) Payment shall be made once the services are delivered, and the Service Provider s ubmits the invoice for the same.
- 16. Payment Process:
- (a) Payment shall be made only after submission of invoices, attendance sheet, logbook, service feedback; non-submission of the same may lead to delay/ deduction in payment.
- (b) All the penalties/ fine/ interest (if applicable) shall be settled before making the payments. Service Provider shall not have any objection on the same.
- (c) Payment shall be made through bank transfer only in no circumstance cash/cheque payment shall be made. GST will be applicable as per the latest GoI notification.
- 17. The contract will initially be valid for 12 months to be extended further as per the GeM guidelines base d on satisfactory performance.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
