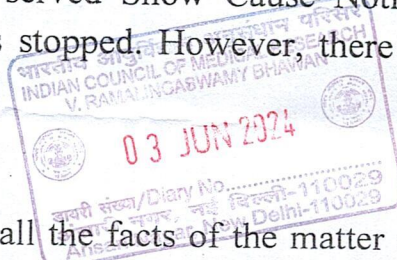
ORDER

WHEREAS the organisation namely Shri Mahila Bal Kalyan and Apang Punarvasan Vikas Mandal has been receiving Grant-in-aid under the Scheme of Integrated Programme for Senior Citizens (IPSrC), a component of Atal Vayo Abhyuday Yojana (AVYAY) from this Ministry for running and maintenance of Senior Citizen Home for 25 beneficiaries at Plot No. 46, Raje Sambhaji Nagar, Sakri Tal, Dhule, Maharashtra.

2. AND WHEREAS the project of "Senior Citizen Home" of the above organization, which is being run by the organization with financial assistance from this Ministry under the IPSrC Scheme has been found violating the Scheme Guidelines on a consistent basis during the last 4 financial years, wherein for the previous grants i.e. for FY 2020-21, 2021-2022 and 2022-23 and 2023-24, many inspection/re-inspection were conducted each year in respect of this centre and non-recommending report and several deficiencies were found. The Project has been re-inspected nearly five times and deficiencies/irregularities of serious nature were found at the time of every re-inspection.

3. AND WHEREAS the project was served Show Cause Notices and Advisory and the Grants to the project was stopped. However, there was no improvement in the project's working.

4. NOW THEREFORE, after considering all the facts of the matter and going into details of the case, it is noted that the Organisation has been found violating the guidelines of the Atal Vayo Abhyuday Yojana on multiple occasions, which is a serious lapse. Since there is no improvement in the project's

working, the Organisation namely Shri Mahila Bal Kalyan and Apang Punarvasan Vikas Mandal, Dhule, Maharashtra is hereby blacklisted for receiving further grant-in-aid from the Government of India.

3. A framework for the minimum standards for the Senior Citizen Homes have been issued to the necessary infrastructure, facilities, and services available provide a safe, comfortable, and dignified living environment for the senior citizens residing in them. 4. In this regard, I am writing to request your Ministry to consider leveraging the Corporate Social Responsibility (CSR) funds of the enterprises under your jurisdiction. They may consider allocations a portion of their CSR funds for improving the facilities in the Senior Citizen Homes. The participation of these entities in this cause will significantly contribute to the enhancement of these Senior Citizen Homes.

5. We kindly request you to disseminate this suggestion to the relevant institutions under your Ministry and encourage them to contribute towards this purpose.



I am directed to state that the provisions of Model Code of Conduct are enforced from the date of announcement of the election schedule by the Election Commission and it remains in operation till the completion of the election process.

2. Now, that the results in respect of the General Elections to the House of the People (Lok Sabha), 2024 and State Legislative Assemblies in the States of Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim, and certain bye-elections have been declared by the respective Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect except in the Graduates' and Teachers' Constituencies of Karnataka, Maharashtra and Telangana where Model Code of Conduct is in force due to biennial/bye elections to Legislative Council from Graduates & Teachers Constituencies.
