2. Background:

The Indian Council of Medical Research (ICMR), New Delhi, the apex body in India for the formulation, coordination and promotion of biomedical research, is one of the oldest medical research bodies in the world. The ICMR has always thrived to address the growing demands of scientific advances in biomedical research on the one hand and the need of finding practical solutions to the health problems of the country, on the other hand.

The Prime Minister's Science, Technology, and Innovation Advisory Council (PM-STIAC), in its 21st meeting, approved the establishment of the National One Health Mission (NOHM) as an inter-ministerial initiative. The Indian Council of Medical Research (ICMR) has been designated as the implementing agency, with an approved SFC to support R&D, coordination, and intersectoral collaboration.

To promote and showcase the scientific initiatives & programmes of the NOHM, Indian Council of Medical Research (ICMR), New Delhi, is planning to organize a National One Health Mission Conclave in the month of November 2025. This conclave will formally showcase the goals and activities of the National One Health Mission to disseminate the One Health concepts across the country, with a special focus on engaging youth and students.

The National One Health Mission Conclave 2025 aims to bring together key ministries, departments, academicians and international/national experts, offering a unique platform to interact with India's leadership, and congregating various stakeholders with collaborative vision under the National One Health Mission while spotlighting youth-led innovations, scientific research, and multisectoral models that drive progress in health security, sustainability, and climate resilience.

This Expression of Interest (EOI) is intended to invite innovative proposals for organizing National One Health Mission Conclave 2025 align with the core objective of the National One Health Mission as described above. The detailed scope of the identified activities is provided in the subsequent sections of this document.

3. Objective

To collaborate with eligible organizations/professional bodies/academic institutions/ universities and non-governmental organizations (NGOs) for organizing National One Health Mission (NOHM) Conclave 2025.

4. Scope of Work

ICMR is desirous to collaborate with eligible organizations/professional-bodies/academic institutions/universities /non-governmental organizations (NGOs) for one or more of the following activities, based on their interest, scope, experience and capacity

- i. Conducting a national-level hackathon to engage and empower youth in developing innovative, practical, and sustainable solutions that address the themes goals of the National One Health Mission (NOHM).
- ii. Engaging school/college/ university students, faculties and/or institutions for awareness generation about One Health Mission and its approaches
- iii. Creating platforms for showcasing innovations and interdisciplinary collaboration led by the youth/ students/researchers/institutions.
- iv. Creating engaging and interactive sessions for school and college students, such as essay writing, photo contests, short video contests, outreach activities, and quiz competitions, to disseminate the message of One Health.
- v. Organizing nationwide training programs for young researchers and professionals across various disciplines in zoonotic disease diagnosis, epidemiology, and related fields.
- vi. Conducting collaborative seminars/conferences/webinars to broaden the scope of interdisciplinary One Health approach with aim to facilitate knowledge exchange, and augment the interest of the young generation in One Health domain.

Role of ICMR:

- i. ICMR will steer the whole agenda and provide the technical support & guidance for the organizing the National One Health Conclave.
- ii. All the activities for the Conclave will be reviewed/monitored and directed by ICMR and its scientists, ensuring alignment with the objectives of the Mission.
- iii. ICMR has sole discretion of selection of activities proposed by the collaborator and possess all the rights to reject without assigning any reason thereof.
- iv. ICMR will provide technical support through its team of experienced scientists for different activities including planning, supervision, mentoring, product development (if applicable), and implementation, as deemed appropriate.
- v. ICMR shall have no financial implications unless otherwise specified.

Role of Proponents

- i. Selected collaborator shall have capability and provisions to provide all necessary

infrastructure, materials, services, and manpower required for the planning and execution of activities, either directly or through authorized arrangements.

- ii. The collaborator shall keep transparency in organizing activities, planning and share all relevant information, products, and outcomes at any point of time with ICMR.
- iii. The collaborator shall participate in all discussions and activities relevant planning of National One Health Conclave in a professional manner, as mutually agreed upon.
- iv. The collaborator shall allow authorized personnel, scientists, or teams from ICMR to visit, monitor, or oversee any of the activities, as envisaged under this EoI and/or in any subsequent agreement.
- v. The collaborator shall be responsible for obtaining any approvals/permissions, if required, for implementation of the identified activities for National One Health Conclave.

5. Intellectual Property Rights

ICMR shall have the sole right on all the intellectual property arising (generated through the above-mentioned activities) from proposed activities. Due Credit will be given to the collaborator at the sole discretion of Competent authority at ICMR.

6. Publication

- i. ICMR has primarily all the rights of scientific publications, and other outputs (including joint publications, acknowledgments, documentaries/movies or other credits as applicable), and due credits and authorship rights will proportionally be given to the partners/collaborators, in accordance with the guidelines for the time being applicable of the International Committee of Medical Journal Editors, if any (ICMJE, www.icmje.org).
- ii. All publications, manuscripts, or output in whatsoever manner produced by the collaborating organizations/professional bodies/academic institutions/universities/non-governmental organizations (NGOs) directly or indirectly connected must mandatorily duly acknowledge the support of ICMR.
- iii. ICMR shall reserve the primary authorship rights in publications arising from the above-mentioned activities, in accordance with standard scientific and ethical guidelines.

7. Data Rights

- i. In case of 100% funding by ICMR for any activity whatsoever it is, ICMR shall have

exclusive sole right on data generated from such activity.

- ii. In the case of jointly funded activities, the data generated shall be jointly owned by ICMR and the licensee/co-developer, with rights and usage governed by mutually agreed terms.
- iii. Data rights in cases where Artificial Intelligence is involved shall be dealt (in accordance with laws applicable thereto for the time being) separately
- iv. The licensee or company shall ensure that all data is anonymized, kept confidential, and handled in strict compliance with the provisions of the Information Technology Act, 2000 while dealing with such data.

8. Details of documents to be furnished

Proponents are requested to go through all pre-qualification requirements, scope of work for execution & requirements with respect to technical capabilities for submission of interest, subject for verification by ICMR.

Documents to be furnished are as follows:

- i. Declaration - Expression of Interest (Format – 1)
- ii. Authorization Letter (Format – 2)
- iii. Undertaking with regard to Blacklisting (Format-3)
- iv. Undertaking with regard to Non-Conviction (Format – 4)
- v. EoI document with each page duly stamped and signed by the Authorized signatory.
- vi. Supporting documents, as mentioned in Format-1
- vii. Concept note on activity plan (not more than 5 pages)
- viii. Any other information which proponent may wish to provide to support the EoI.

ICMR reserves the right to call for any clarifications confined in the broad scope, wherever such a clarification become necessary for proper judgement in evaluation.

9. Rejection Criteria

The application is liable to be rejected without any further notice if:

- i. The proposal is not submitted as per the requirements indicated in the EoI.
- ii. Not in the prescribed format.
- iii. Not properly stamped and signed.
- iv. Received after the expiry of due date and time.
- v. All relevant supporting documents are not furnished with the Pre-Qualification Criteria (PQC).
- vi. The proposal shall be substantially responsive without any material deviation, failing which

the proposal shall be summarily rejected.

- vii. Applications not fulfilling the terms of the document will be summarily rejected.
- viii. Any other non-compliance deemed as such by the competent authority

10. Evaluation Methodology

Screening of submitted EoIs will be conducted as per the pre-qualification criteria outlined in the EoI document and based on verification of the supporting documents provided. Preference will be given to professional organizations with wide outreach or to academic institutions and universities with a proven track record of successfully conducting similar activities successively/repeatedly.

11. Pre-Qualification Criteria (PQC)

The following will be the minimum Pre-Qualification Criteria (PQC). Responses not meeting the minimum PQC will be summarily rejected and will not be evaluated further:

12. Arbitration

- i. Any dispute or differences whatsoever arising between parties out of or relating to this EOI including the interpretation, validity, or breach thereof, which cannot be amicably settled by mutual consultation within a period of 30 days from the date either party notifies the other of such dispute, shall be referred to and finally resolved by arbitration
- ii. The arbitration shall be conducted by a sole arbitrator appointed in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactments thereof for the time being in force.
- iii. The Seat and Venue of the arbitration proceedings shall be New Delhi, India
- iv. The courts at New Delhi shall have exclusive jurisdiction to entertain and try all suits, proceedings, or matters arising out of or concerning this EOI, including any challenges to the arbitration award.
