

Access to sanitary pad vending machines and incinerators in public infrastructure promotes menstrual hygiene by offering convenient access to sanitary pads, especially in areas where availability might be otherwise limited.
- Providing such easy access empowers women to manage their menstruation with dignity and reduces the stigma associated with it. They can participate fully in both public & private spaces. Additionally, the installation of incinerators ensures the safe disposal of used sanitary products, addressing environmental concerns and preventing health hazards from improper disposal practices.
- In this context, I would like to bring to your notice a very good initiative of the Department of School Education & Literacy wherein vide letter dated 07.06.2024, they have written to the Education Departments of all the States/ UTs to take proactive measures for supporting health and dignity of female students through the provision of sanitary products, conducting sensitisation and awareness programmes and by ensuring confidentiality and privacy. In an earlier D.O. letter dated 27.02.2024 this Ministry had also written to the Secretaries of all Ministries/ Departments and Chief Secretaries / Administrators of all States/ UTs seeking support in creating gender friendly workplaces which includes installation of Sanitary pad vending machines and incinerators in all female washrooms (Copy enclosed).

As you are aware the new version of SHe - Box has been launched by this Ministry which will serve as a central repository of data and complaints under "The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (SH Act)" across the country. The SHe-Box portal is live now. The User login details of each Ministry/Department and States/ UTs have already been shared vide communication dated 02.09.2024.

- 2. The SHe- Box portal has been designed for effective implementation of the provisions of the SH Act, 2013. The Hon'ble Supreme Court has also passed directions for strict compliance of the provisions of the Act in the matter of Aureliano Fernandes Vs State of Goa & Ors. The structure of the portal has been so designed that in the absence of uploading of information of Internal Committee (IC)/ Local Committee (LC) by the office/ authority concerned, the complainant won't be able to lodge her complaint through the portal to the IC/ LC under which her workplace falls. Therefore, it is essential for all the Central Ministries/ Departments as well as all workplaces within their respective jurisdiction to feed the required information immediately as per the provisions of the SH Act.
- 3. I, therefore, request you to kindly look into the matter and direct the officers concerned to post the details of Nodal Officers and IC/ LC latest by 13.09.2024. This item is being reviewed at the highest level and compliance is also to be reported to the Hon'ble Supreme Court.
