

OFFICE MEMORANDUM

Subject: Proclamation issued under article 356(1) of the Constitution in respect of the State of Manipur

A copy of the Proclamation by the President notified on 13th February, 2025 under article 356 of the Constitution in relation to the State of Manipur is enclosed.

- 2. Consequent on the assumption by the President of all the functions of the State Government of Manipur and of the powers vested in or exercisable by the Governor of that State under the Constitution and the different laws in force in that State, it has been decided that for the sake of expeditious conduct of business at the Centre, all matters and references relating to Manipur will be dealt with in the manner indicted below:-
- a) Ministries/Departments which already deal with matters relatable to the Union or Concurrent List of Seventh Schedule to the Constitution will do so in accordance with the Government of India (Allocation of Business) Rules, 1961. In addition, Ministries/Departments will also deal with other matters in List II (State List) of the Seventh Schedule to the extent that they are relatable or relevant to their sphere of business or functions. Such matters will include all Government business, such as Bills, Parliament Questions and other references;

b) The State Government of Manipur is being advised to correspond directly with the concerned Ministries/Departments of the Union Government in regard to matters requiring decision of disposal in accordance with the procedure mentioned at (a) above;

c) In doing so, the State Government will forward to this Ministry copies of references (sent by them to other Ministries/Departments) which in their opinion are important and may require to be dealt with in consultation with other Ministries;

d) Parliament business will also be attended to within the framework of the procedure outlined in (a) to (c) above.

This information on receipt will be compiled and circulated to all Ministries and the State Government of Manipur for their information and ready reference.

Subject:- Laying of Statutory Rules, Notifications, Orders, etc. on the Table of the two Houses of Parliament.

Sir.

I am directed to say that on assumption of the functions related to the State of Manipur by the President from 13th February, 2025, Statutory Rules, Notifications, Orders etc. which might have been framed and which were statutorily required to be laid before the State Legislatures by the State Government (but were not laid), will now be required to be laid before both the Houses of Parliament. Every such Rule, Order etc. is required to be laid within a period of 30 days from its publication thereof in the State Government Gazette, if the House is in session, and if the House is not in session, within a period of 30 days after the commencement of ensuing session of Parliament.

2. It is, therefore, requested that 70 copies of the Rules/Orders etc (both in English and Hindi) that may be notified from time to time in the State Government Gazette may please be sent to the Administrative Ministries concerned with the subject matter of the Rules/Orders etc. for laying them on the Table of both Houses of Parliament under intimation to this Ministry together with three copies of these Rules/Orders. Cases in which the above limit could not be adhered to by the State Government, should be accompanied by a Statement giving adequate reasons for the delay.
