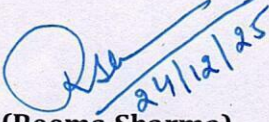

In compliance of the directions dated 04.12.2025 of the Hon'ble CAT, Principal Bench, New Delhi in OA No. 849/2025, the final result of candidates selected in the Limited Departmental Competitive Examination (LDCE) for the post of **Assistant (Level 6 of Pay Matrix; Rs. 35,400-1,12,400)** at ICMR Headquarters & its Institutes/Centres held on **08th December, 2024 (Sunday)** through AIIMS, New Delhi, has been redrawn and the revised final result is attached herewith (**Annexure-I**).

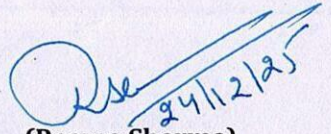

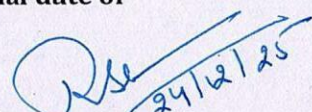
