Subject: Promotion to the post of Senior Accounts Officer in ICMR-reg.



In case the officer opts to continue on ex-cadre post, an appropriate proposal from the borrowing authority concerned is required to be forwarded to this Department within 20 working days of issuance of this order, for consideration of grant of proforma promotion in terms of extant instructions. Only on grant of proforma promotion, notification for regular promotion shall be issued by ICMR.

3. The promotion will remain subject to further orders of the Hon'ble Supreme Court of India in the Civil Appeal No. 629 of 2022 arising out of the SLP(C) No. 30621/2011 titled Shri Jarnail Singh & Ors. Vs Lachhmi Narain Gupta & Ors. and other connected matters.
