All concerned Institutes/Centres/HQ are requested to relieve the above-mentioned officials on duty to enable them to attend the Induction training program.

It shall be mandatory for all participants to stay at the AJNIFM campus during the training period. Local participants may visit their homes only on Sundays; however, they must return to the campus and stay there from Monday to Saturday throughout the duration of the program.

TA/DA in respect of the participants shall be borne by their respective ICMR Institutes/Centres/HQ, as per applicable rules and entitlements. Free boarding and lodging shall be provided at the training centre. However, DA for the transit period may be claimed as per rules. All participants shall invariably stay in the campus accommodation during the period of the training.
