**OFFICE ORDER**

Sub: - Joining to the post of Accounts Officer in ICMR-reg.

With reference to the Letter No. 6-2(12)/2023-Estt. dated 02<sup>nd</sup> April, 2026, and with the approval of Competent Authority, the following candidates are hereby appointed temporarily to the post of Accounts Officer on direct recruitment basis in Indian Council of Medical Research (ICMR) in the Pay Level 10 (Rs. 56,100 – 1,77,500) of Pay Matrix plus usual allowances as admissible under the rules from time to time, with effect from the date of their joining, as mentioned against each: -

2. The appointment is provisional and subject to medical examination by a duly constituted Medical Board by the Government Hospital and verification of character & antecedents, caste Certificate (if applicable) from the concerned authorities as per prescribed procedure.

3. They will be on probation for a period of two years from the date of joining. However, the Competent Authority may extend the probation in accordance with the instructions issued by the Central Government from time to time.

4. Orders of Posting of above officers will be issued separately in due course.

5. They will be governed by the usual terms and conditions of service under the Council.

6. Their pay will be fixed in terms of recommendations of 7<sup>th</sup> Central Pay Commission and CCS (Revised Pay) Rules, 2016.

7. The expenditure involved on this account may be met from the provision made under head "Pay & Allowance" in the budget of the Hqrs. Office of the Council for the year 2026-2027.
