OFFICE ORDER

Sub: - Joining to the post of Accounts Officer in ICMR-reg.

With reference to the ICMR's Letter No. 6-2(12)/2023-Estt. dated 02nd April, 2026 and 24th April, 2026, and with the approval of Competent Authority, the following candidate is hereby appointed, temporarily to the post of Accounts Officer through direct recruitment in Indian Council of Medical Research (ICMR) in Pay Level 10 (Rs. 56,100–1,77,500) of Pay Matrix, along with usual allowances admissible under the rules from time to time, with effect from the date of his joining. 2. The appointment is provisional and subject to medical examination by a duly constituted Medical Board by the Government Hospital and verification of character & antecedents, caste Certificate (if applicable) from the concerned authorities as per prescribed procedure.

3. He will be on probation for a period of two years from the date of joining. However, the Competent Authority may extend the probation in accordance with the instructions issued by the Central Government from time to time.

4. He will be governed by the usual terms and conditions of service under the Council.

5. His pay will be fixed in terms of recommendations of 7th Central Pay Commission and CCS (Revised Pay) Rules, 2016.

6. The officer shall be treated as under posting until he join his respective place posting.

7. TA and joining time shall be admissible to the officer as per rules.

8. The expenditure involved on this account may be met from the provision made under head "Pay & Allowance" in the budget of the Hqrs. Office of the Council for the year 2026-2027.

9. Other terms & conditions of Letter No. 6-2(12)/2023-Estt. dated 02nd April, 2026 will remain same.
