

Towards this goal, The One Nation One Subscription (ONOS) was launched in November 2024 to provide country-wide access to scholarly research articles and journal publications to all Higher Educational Institutions (HEIs) managed by the central government and state governments and Research & Development Institutions of the central government. As of now more than 6000 institutions are onboarded into ONOS.

2. Article Publishing Charges/Article Processing Charges (APC) is one of the components of the ONOS scheme. APCs for selected good quality open access journals will be centrally funded through the INFLIBNET. The APC module in the ONOS portal is live and payments towards APC has been made for accepted research articles. Detailed procedure is available at <https://www.onos.gov.in/apc-support>.

3. I would be grateful if you could give wide publicity among researchers in your organizations/institutes so that the faculty and students of your institute can avail of APC charges through ONOS.

Eligibility & Selection Criteria

- Scientists or medical professionals residing within or outside the country who has made a significant contribution with proven record of research in Medical or Biomedical science and Technology or Indian Systems of Medicine.
- The nominee shall not be over 70 years of age on the last date for receipt of nomination.
- The nominee should possess an outstanding academic record with a proven history of intellectual leadership, significant internationally recognised research contributions, high- impact publications, patents, or pioneering advancements in their domain.

Sir/Madam,

Kindly refer to above-cited letters.

2. It is stated that the Central Government has notified the Transport of Animals Rules, 1978 (as amended in 2001 and 2009) and Prevention of Cruelty to Animals (Slaughter House) Rules, 2001 (as amended in 2010) to prevent unnecessary pain or suffering to animals. It is a fact that large numbers of animals are illegally transported and slaughtered for food especially during festivals. It is reported that during transportation of animals, the owner of the animals does not follow the animal welfare laws, which result in cruelty to the animals and even some of the animals die during transportation.

3. As you may be aware, cruelty to any animal is a punishable offence under the Prevention of Cruelty to Animals Act, 1960. Such violation is against the spirit of Article 48, 48 (a) and 51 A(g) of the Constitution of India.

4. The Brief of Transport of Animals Rules, 1978 (as amended in 2001 and 2009) and Prevention of Cruelty to Animals (Slaughter House) Rules, 2001 (as amended in 2010) along with the various circular, advisories, judgements and other relevant laws are attached at **Annexure**.

5. Therefore, it is requested to kindly direct all the concerned authorities to take all precautionary measures for strict implementation of the Animal Welfare laws to stop illegal transportation of animals or killing of animals and to take stringent action against the offenders violating the animal laws. The concerned authorities are also requested to sensitizing the public through posters, social media, twitter and other forms of electronic media. It is also requested to direct

the concerned authorities to forward a detailed report on quarterly basis on the status of enforcement of the above laws, to the Board for taking further necessary action in the matter.

A line of confirmation in this regard is highly solicited.
