OFFICE MEMORANDUM

Subject: Compliance with the Hon'ble High Court of Delhi's Order dated 22-05-2026 in Contempt Case No. 869/2015 in WP Civil No. 5710/2011 (Rohitash Singh Vs. UOI & Ors.) - Reversion to Merit Based Assessment Promotion Scheme (MBAPS) for Technical Staff-reg.

The undersigned is directed to invite reference to ICMR Hqrs earlier communications regarding the implementation of the Integrated Recruitment and Assessment Scheme (IRAS) for the technical employees who had previously submitted affidavits before the Hon'ble High Court claiming IRAS benefits.

2. In view of the **Order dated 22-05-2026** passed by the Hon'ble High Court of Delhi disposing off contempt proceedings & CM Appl.34408/2026, the Competent Authority has decided to extend the benefit of **Merit Based Assessment Promotion Scheme (MBAPS)** to those members of the technical staff who had earlier opted for IRAS.

3. The ICMR Hqrs /Institute/Centers are further directed to ensure that no recovery and deductions shall be made from the salaries/pension of such employees who had earlier opted for IRAS.

4. Their assessment and promotion shall be regularized under MBAPS guidelines, followed by the applicable Recruitment Rules for the technical cadre i.e. Integrated Recruitment and Assessment Rules, 2017.

5. It shall be the primary responsibility of the ICMR Hqrs and respective Institute/Centre to strictly adhere to these compliance directives.
