The undersigned is directed to invite kind attention to the Office Memorandum No. 13013/20/2024-Policy dated 07.04.2026 issued by the Department of Empowerment of Persons with Disabilities (D/o EPwD), Ministry of Social Justice & Empowerment, forwarding therewith the representation dated 27.03.2026 submitted by the All India Central Government Deaf Employees' Association (AICGDEA), along with the communication/order dated 31.01.2025 issued by the Office of the Chief Commissioner for Persons with Disabilities (CCPD), for appropriate action.


The undersigned is directed to say that the proposal has been received in this Department for consideration of employees appointed on compassionate ground for inclusion under old pension scheme in accordance with the principle underlying the DOPPW OM dated 03.03.2023 by fixing a date of advertisement in their case. It was also requested by the staff side during the meeting of National Council (JCM) held on 25.02.2025 under the Chairmanship of Secretary (Pension) that the facility of coverage under OPS be extended to compassionate ground appointees who had submitted their application before 01.01.2004 but were appointed after 01.01.2004. Further, it was highlighted that there is no Notification/Advertisement in the case of appointments on compassionate grounds.

2. After inter-ministerial consultation and examination in consultation with the Department of Expenditure and DoPT, it has been decided that the date of application for Compassionate Appointment shall be considered as the crucial date for compassionate appointments provided that the applicants were eligible to be considered for appointment at the time of their application.

The family member who is eligible for being considered for appointment and have applied for compassionate appointment on or before 31.12.2003, shall be considered under CCS (Pension) Rules, 2021 by the concerned Ministries/Departments


3. All Ministries/Departments are requested that the above instructions may be considered in all such cases of compassionate appointments.

Dear Colleague,

I would like to draw your attention to my earlier D.O. letter dated 11.07.2025 regarding the launch of nationwide organ donation awareness campaign, “Angdaan–Jeevan Sanjeevani Abhiyaan” (अंगदान – जीवन संजीवनी अभियान). Hon'ble Prime Minister, in the 131st episode of *Mann Ki Baat*, has also reiterated the importance of organ donation and highlighted its transformative impact on the lives of recipients and their families.

2. Building on the momentum generated by the above, significant progress has been achieved in the field of organ donation and transplantation in the country. As per records, 3,475 deceased-donor transplants were performed during 2025. Further, since the launch of the campaign, 1.87 lakh (approx..) organ donation pledges have been registered on the online pledge portal of the National Organ and Tissue Transplant Organization (NOTTO), indicating a substantial increase in public awareness and willingness to contribute to the cause of organ donation.

3. In continuation of these efforts, I would request that officials working in the attached/subordinate offices, autonomous bodies, public sector undertakings, educational and healthcare institutions, etc. of your Ministries/Departments may be sensitized on organ donation through workshops, awareness talks, exhibitions, social outreach activities, and other suitable initiatives. We may encourage public to pledge for donation of Organs/Tissues by following simple steps through website <https://notto.abdm.gov.in>.

4. Government offices may also disseminate IEC materials on organ donation through website, digital displays, social outreach activities, and other suitable initiatives.
