3. General Conditions for all the posts:

Period of contract	Initially for a period of 1 year, can be extended in accordance with DoCA guidelines dated 3 rd February, 2022.
Method of recruitment	Contract based, through open market.
Age limit	Not exceeding 32 years of age on the last date of submission of applications.
Remuneration per month	An initial consolidated amount Rs 40,000/- per month.

4. Other terms and conditions are as under:

- a. **Period of engagement:** The engagement in Department of Consumer Affairs will be initially for a period of 1 year. The engagement can be extended up to 3 years - one year at a time, subject to factors mentioned in DoCA guidelines 3rd February, 2022.
- b. **Leave:** Leave of 8 days shall be allowed in a year on pro-rata basis.
- c. **Tax Deduction at Source:** TDS as applicable under the rules shall be deducted from the monthly remuneration. A TDS certificate shall be issued by the concerned DDO on demand.
- d. **Allowances:** No TA / DA shall be admissible for joining the assignment or on its completion. No other facilities such as DA, accommodation, reimbursement for phone / conveyance / transport, foreign travel, personal staff, medical reimbursement, CGHS etc. would be admissible to the YPs. Individual Sr. YP/YP may be required to undertake domestic tours for official purposes subject to approval of the competent authority. They will be allowed to avail journey by air in Economy class or by rail in AC Two Tier. Hotel accommodation of upto Rs 2250/- per day, taxi charges of upto Rs 338/- per day for travel within the city and food bills not exceeding Rs 900/- per day shall also be allowed. The matters related to tours and reimbursements related to tours shall be processed by concerned reporting officer.
- e. **Shifting and transfer:** As these positions are temporary in nature and purely contractual, in no case any request of a candidate from YP Category-I to Sr. YP shall be entertained. YP already engaged in DoCA and YP Category-I may apply for Sr. YP and if found suitable can be selected as Sr. YP. Transfer of YP from the Division / Section for which he/she was selected to other Division / Section is also not permissible. However, in exceptional case, if approved by Secretary (CA), Division/Section can be changed.
- f. **Enhancement in remuneration:** In case the engagement of Sr.YP/YP is extended, the remuneration shall be enhanced by Rs 5000/- annually. The enhancement in remuneration will be based on YP's performance during the year after recommendation of concerned Division which shall be subject to concurrence of IFD and approval of Secretary (CA).
- g. **Termination of engagement:** The assignment is purely contractual and the engagement of Sr. YPs/YPs can be terminated by DoCA after giving one month's notice. However, DoCA reserves the right to terminate the engagement of any YP at any time without prior notice and without providing any reason for it. Further, DoCA

may terminate the engagement of any YP without prior notice in the case of breach of provisions of contract / terms of engagement. The engagement of a YP will be terminated at the end of tenure, if not extended. In cases where DoCA terminates the engagement of YP without giving prior notice, the YP shall be paid proportionate remuneration in lieu of the notice.

I. COMPANY PROFILE

Bharat Sanchar Nigam Limited (BSNL) was incorporated in September 2000 under the Companies Act, 1956 with the objective to take over the business of providing telecom services and network of the erstwhile Department of Telecom Services and Department of Telecom Operation of the Department of Telecommunications with effect from 1st October, 2000. The Company is providing Telecom Services throughout the country. BSNL is a Schedule 'A' / Miniratna Central Public Sector Enterprises (CPSEs) under the administrative jurisdiction of the Department of Telecommunications.

The company employed 52183 regular employees (Executives 28968 and Non-executives 23215) as on 31.03.2026.

Its registered and corporate offices are at New Delhi.

The authorized and paid up capital of the Company were Rs. 2,10,000 crore and Rs. 1,71,516,68,58,270/- respectively as on 31.03.2026 (including 750,00,00,000 9% non-cumulative preference share of ₹ Rs. 7500 crore).

The shareholding of the Government of India in the company is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director of BSNL is the chief executive of the company and accountable to its Board of Directors and the Government of India.

His/her overall responsibility is to manage the company successfully, which includes strategy formulation, planning, development and operations of its network, as well as management of its personnel, finance, commercial and marketing activities with emphasis on continuous improvement of the company's performance by encouraging performance-oriented work culture within the organisation. He/she is also responsible for achieving its corporate objectives and performance parameters, including strategic, operational and financial parameters, while driving the revenue growth from various segments, viz., Operations of Consumer Fixed Access, Consumer Mobility and Enterprise Business. Further, his/her job profile also covers successful execution of government projects as well as achieving the objectives of revival package approved by the Government of India.

III. ELIGIBILITY

1. MINIMUM AND MAXIMUM AGE AS ON THE CLOSING DATE OF RECEIPT OF APPLICATION

For all applicants, the minimum age will be 45 years and maximum age will be 59 years.

2. EMPLOYMENT STATUS

The applicant must, on the date of application as well as on the date of interview, be employed in a regular capacity — and **not** in a contractual/*ad-hoc* capacity — in one of the following:

- (a) CPSE (including a full-time functional Director on the Board of a CPSE);
- (b) Central Government Group A officers, including the Armed Forces of the Union and All India Services and officers from Public Sector Banks/Financial Institutions/Autonomous Bodies etc.;
- (c) State Public Sector Enterprise (SPSE) where the annual turnover is ***₹2,000 crore or more;**
- (d) Private Sector company where the annual turnover is ***₹2,000 crore or more.**

Applicants who retired from Board level position on whole-time basis from private sector company where annual turnover is Rs. 2,000 crore or more, shall also be eligible.

Preference would be given to candidates from listed entities.

*(*The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised, shall be considered for applying the approved limit)*

*(*For retired Private Sector applicants, the average audited annual turnover of three financial years preceding the calendar year in which the applicant retire, shall be considered for applying the approved limit)*

3. QUALIFICATION

The applicant should be an Engineering graduate/Chartered Accountant/Cost Accountant / Post Graduate/Graduate with MBA/Post Graduate Diploma in Management from a leading institute.

4. EXPERIENCE

- i. The applicant should possess cumulative experience/exposure for at least five years during the last ten years in Finance/Business Development/Production/Operations/Marketing/Project Management in a large organisation of repute.

Or

- ii. The applicants should possess cumulative experience of at least 5 years in core HR/IR/Personnel Management along with at least 3 years cumulative experience during last 10 years in Finance or Business Development or Production or Operations or Marketing or Project management in a large organization of repute.

Overall managerial and leadership experience in the telecom sector would be preferred.

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the closing date of receipt of application.

B.

- (i) **Applicants from Central Government, including All India Services (AIS) and Autonomous Bodies etc.,** should be holding a post of the level of Additional Secretary in the Government of India or carrying equivalent scale of pay on substantive basis on the date of application.
- (ii) **Applicants from Public Sector Bank/Financial Institutions** should be holding at Board level or at least a post of the level immediately below the Board level for one year on the date of application.
- (iii) **Applicants from the Armed forces of the Union** should be holding a post of the level of Lieutenant General in the Army or equivalent rank in the Navy/Air Force on the date of application.
