Subject: Applicability of gazette Notification No.FX-4/2/2025-PR dated 13.11.2025 issued by the Dept of Financial Services (DFS), Ministry of Finance to the employees of Central Autonomous Bodies covered under NPS.

The undersigned is directed to refer to the Department of Financial Service's Notification No.FX-4/2/2025-PR dated 13.11.2025 providing following two more investment options to NPS subscribed Central Govt. Employees.

(i) Aggressive Life Cycle Fund with maximum exposure to equity capped at 75% - LC-75.

(ii) Balanced Life Cycle Fund with maximum exposure to equity capped at 50%, with tapering of equity component commencing from the age of forty-five years – BLC

2. Consequent upon issue of this Notification, Pension Fund Regulatory and Development Authority (PFRDA) have been receiving representations from employees of Central Autonomous Bodies (CABs) seeking extension of the aforesaid investment options. The matter has been examined in this department and it has been decided that the applicability of DFS Notification No.FX-4/2/2025-PR dated 13.11.2025 may be extended to the NPS subscribed employees of the CABs.

3. The concerned Administrative Ministries/ Departments may consult PRRDA/Central Record Keeping Agency (CRA), if any, technical support is needed for implementation of the above provisions.

Dear Mr. Bahl,

As you are aware, Government of India launched the Har Ghar Tiranga (HGT) campaign in 2022 under the aegis of Azadi Ka Amrit Mahotsav. The objective of this campaign has been to encourage citizens to hoist the National Flag at their homes and build a personal and emotional connection with the Tiranga. Over the years, the campaign has become a successful Jan Bhagidari movement of national identity, patriotism and pride.

2. The HGT campaign was successfully implemented during the years 2022, 2023, 2024 and 2025, with the Tiranga being prominently hoisted across homes, offices, institutions and public spaces nationwide on Independence Day. Activities such as Selfie with Tiranga, Prabhat-pheris, Tiranga Rallies (including bike and cycle rallies), Tiranga exhibitions, along with other grassroots-level Jan Bhagidari initiatives, have made the Independence Day celebration a more participative and widely celebrated occasion across the country. The campaign has also served as a special occasion for the public to pay heartfelt tribute to the freedom fighters and soldiers who laid down their lives in the service of the nation and in honour of the Tiranga.

3. In continuation of this spirit, Government of India is currently commemorating 150 years of the National Song "Vande Mataram". In this regard, the National Implementation Committee (NIC), under the Chairmanship of the Hon'ble Union Minister of Home Affairs and Cooperation, has approved, vide its directions dated 13.03.2026, the integration of the third phase of the commemoration with Har Ghar Tiranga 2026. Accordingly, Government of India has decided to celebrate Har Ghar Tiranga 2026 across the country from 9th to 17th August 2026. During this period, all physical celebrations shall bring together singing of the National Song "Vande Mataram" and hoisting/display of the National Flag (Tiranga). Similarly, all digital celebrations shall also bring together these two components through the Har Ghar Tiranga website (www.harghartiranga.com), wherein citizens may upload Selfie with Tiranga and the lyrics of "Vande Mataram" shall automatically appear as part of the uploaded picture.

4. Further, in accordance with the directions of the National Implementation Committee (NIC), your Ministry is requested to actively support the Har Ghar Tiranga 2026 campaign. The activities to be undertaken by Department of Health Research, Ministry of Health & Family Welfare towards HGT 2026 are highlighted in Annexure-I.

5. In the above context, it is requested to kindly nominate a Nodal Officer from your Department to coordinate with the Ministry of Culture for effective implementation of the HGT 2026 campaign.

ANNEXURE-I

Har Ghar Tiranga 2026 Activities to be undertaken by Ministry of Health & Family Welfare (D/o DHR)

A. Ministry/Department-specific Activities

1. The Department may issue suitable directions to the **Indian Council of Medical Research (ICMR)** and all research institutes and autonomous organizations under its administrative control to undertake activities under **Har Ghar Tiranga 2026**.
2. Flag hoisting ceremonies and collective singing of the National Song "**Vande Mataram**" may be organized at ICMR Headquarters, National Institutes and Regional Research Centres.
3. Scientists, researchers, technical staff, students and other personnel associated with medical research institutions may be encouraged to actively participate in **Har Ghar Tiranga 2026**.
4. Research institutions may undertake suitable outreach and awareness activities promoting the spirit of **Har Ghar Tiranga 2026**.

B. General Instructions (Applicable to all Ministries/Departments)

5. Encourage officers, employees and the general public to upload "**Selfie with Tiranga**" on the **Har Ghar Tiranga Portal** (www.harghartiranga.com). As part of the digital campaign, the lyrics of the National Song "**Vande Mataram**" shall automatically appear as part of the uploaded picture.
6. Display the **Tiranga Exhibition** curated by the Ministry of Culture (available in the download section of the Har Ghar Tiranga Portal), wherever feasible, at offices and public places under the administrative control of the Ministry.
7. Publicise the campaign through the official website and social media platforms of the Ministry/ Department.

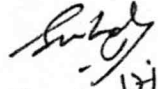
Subject: Revision of flat rate of licence fee for General Pool Residential Accommodation (GPRA) throughout the country.

In terms of the provisions of the Rule 74 of the "Central Government General Pool Residential Accommodation Rules 2017", the Government has decided to revise the flat rates of licence fee recoverable for the residential accommodation available in General Pool and also in Departmental Pools of Ministries/Departments of the Government of India throughout the Country (except in respect of substandard/unclassified accommodation of Ministry of Defence, accommodation for service personnel of the Ministry of Defence and accommodation under the control of Ministry of Railways), as shown in the Annexure.

2. The revised rates of licence fee would be effective from 1st July, 2026. All Ministries/Departments are requested to take action to recover the revised licence fee in accordance with these orders in respect of accommodation under their control all over the country.

3. This issues with the concurrence of Integrated Finance Wing of the Ministry of Housing and Urban Affairs vide their note dated 07.07.2026.
