ICMR – NIRRCH may increase or decrease the requirement by 50%.

Bidder should quote separately for Mixed gas 10% CO₂ + 10% H₂ + 80% N₂

TERMS & CONDITIONS

1. Tenders (Two Bids – Technical Bid and Financial Bid, together in a big envelope) should reach ICMR-National Institute for Research in Reproductive and Child Health, Jehangir Merwanji Street, Parel, Mumbai 400012, Maharashtra before the prescribed date and time mentioned in the Tender.
2. Necessary permissions / licenses as required for the specified services / works to be possessed by the bidder, the lack which is a criterion for disqualification technically.
3. The tender not submitted as per the above prescribed manner will be treated as invalid. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
4. Tender should be accompanied by an undertaking wherein it may be stated that 'If they withdraw or modify their bid/s during period of validity etc. they will be suspended as per the directions of competent authority of the Institute'. The offer without Undertaking would be summarily rejected.
5. The last date for receipt of tenders in NIRRCH is 29th July 2024 up to 17.00 hrs. The offers received would be verified on 31st July 2024 at 11.00 hrs.
6. The successful tenderers will have to submit Demand Draft / Bank Guarantee in favour of Director, ICMR - NIRRCH, equivalent to 5% of the order value/contract cost (towards security of performance), which will be retained for a period of 14 months from the date of submission of the Bank Guarantee
7. The Director reserves the right to exempt from said submission in case of low value orders.
8. The Director, ICMR - NIRRCH, reserves the right to call for break-up of the quotation if it is found necessary. Incomplete specifications offered by the tenderer(s) will not be considered and are liable to be rejected.
9. The offers should be kept valid for acceptance for a period up to 31st October 2024
10. The payment will be arranged as per extant Government Rules and Regulations or 04 weeks. Bills should be submitted monthly.
11. The tendered price should be quoted as the basic cost, without taxes and duties which may be indicated separately.
12. Conditional offers will not be accepted and liable to be rejected without any further reference.
13. Successful bidder should fill the liquid nitrogen cylinders / cryocans located in various departments on request through email from the end user Departments in quantities (Eg., 60L, 90L, 120L, etc.) as per the requirement of concerned lab within 24 hours.

14. The bidders must have requisite licenses to carry out the trade / business in supply of Animal Feed and the documents are to be submitted.

15. Penalty of 0.1% of the total value of the annual order will be levied for each day of delay after the first 24 hours.

16. The contract for supply of Liquid Nitrogen and mixed gases against this tender may be extended further for a period of one year with the successful bidder(s) on mutual agreement basis at the same prices quoted against this tender.

17. The Institute may have simultaneous contracts with more than one supplier for supply of Liquid Nitrogen and Mixed gases as per the discretion of the Director, ICMR – NIRRCH.

18. The Director, ICMR-National Institute for Research in Reproductive and Child Health (NIRRCH), Mumbai reserves the rights to accept or reject any lowest tender in full or in part of any tender or all tenders without assigning any reasons.

19. Financial Evaluation will be item wise.

20. Any of the disputes if arise between the Supplier/Tenderer and the NIRRCH/ICMR shall be resolved by the sole arbitrator which will be appointed by mutual consent of both the parties thereof failing which one of the Director of other Institute of ICMR in Mumbai (NIIH or NIV) shall be appointed within 30 days from the date of cause of action of dispute and the award as may be given by the sole arbitrator shall be binding on both the parties within the Civil Jurisdiction of Hon'ble High Court of Bombay.
