- (i) Copy of the downloaded Registration Slip of the on-line application form.
- (ii) Copy of downloaded Admit Card.
- (iii) Certificate showing the Date of Birth.
- (iv) Caste certificate/Income & Asset Certificate as applicable if applied under SC/ST/OBC/EWS category issued by the competent authority.
- (v) Disability Certificate, if applied under PWBD category.
- (vi) Certificate from the competent authority in a case where age relaxation has been sought for the basis other than caste/PWBD
- (vii) 'No Objection Certificate' if in Central Government/PSU/Autonomous/State Government employment.


- (viii) Educational qualification
- (ix) Experience Certificate must include Name, Designation, Pay Scale/Salary, Department/office name and address, duration and nature of duties performed.
- (x) Salary Slips, Offer letters, joining letters, relieving letters etc. in support of experience, shall not be entertained.
- (xi) The applicants working in Centre/State Government Department/ Public Sector Undertakings & Govt.funded research agencies, must submit a "No Objection Certificate with vigilance clearance and Integrity Certificate" from the employer with an undertaking that "the applicant will be relieved within one month of his/her receipt of appointment order"
- (xii) Two recent passport size photographs.
- (xiii) Checklist attached (duly filled).
- (xiv) Any other certificate(s) as required to submit.

3. The candidates are requested to reach the venue for document verification at least 45 minutes prior to the scheduled time.

4. The candidates must further note that they should carry all the required documents, as mentioned above. No additional time will be given to submit any document.

5. Merely the fact that the candidate qualified in the CBT and called for verification of documents does not confer upon him/her, any right to be called for interview or selection to the post.
