**Subject: Notice for interview for the post of Administrative Officer & Accounts Officer at ICMR, New Delhi – Reg.**

This refers to AIIMS, New Delhi Notice no. 323/2025 dated 11/10/2025 regarding filling up of 10 posts of Administrative Officer and five posts of Accounts Officer under ICMR in Level 10 of Pay Matrix (Rs.56,100-1,77,500) (7th CPC Scale).

2. As per recruitment notice, the total number of candidates eligible to be called for the interview will be five (5) times the number of post advertised in various categories (UR/EWS/SC/ST/OBC/PwBD) based on merit in Stage-I (CBT).
3. Accordingly, the list of eligible candidates shortlisted for interview for the posts of Administrative Officer & Accounts Officer is enclosed herewith as **Annexure I & II**, respectively.
4. The final merit list(s) for all categories i.e. UR/EWS/SC/ST/OBC/PWBD will be made on the basis of combined marks obtained in Stage-I (CBT) & Stage-II (Interview) of the candidates who appeared in both stages of selection process.
5. All the shortlisted candidates listed in Annexure-I & II (enclosed) (roll nos. not in order of merit), are informed to appear for interview, as per the scheduled date and time.
6. The candidates have an option to answer either in Hindi or English during the interview. They have to physically attend the interview. No TA/DA shall be paid for attending the interview.
7. Their candidature for interview is purely provisional and subject to fulfillment of all eligibility criteria, as prescribed for the respective post, in the advertisement notice. The candidates (as mentioned in the remarks column of the annexure) are informed to submit the requisite documents at the time of interview, failing which their candidature will not be considered for the said post.
8. Canvassing directly or indirectly and using external influence will disqualify the candidature.
9. ICMR reserves the right to cancel the process, if considered necessary, at any stage of selection/appointment.
