Attention is drawn to the communication cited under reference.

2. AIIMS, New Delhi, vide Result Notification no. 239/2026 dated 06.08.2026, has declared the list of provisionally qualified candidates.

3. As per paras 5 & 5.1 of Council's Circular dated 16.04.2026, the results shall be declared separately for each year to ensure that if vacancies remain unfilled in the year 2025, the same are carried forward to next vacancy year 2026. Further, year wise merit list will be based on the number of vacancies, candidate's merit and fulfilment of all other eligibility conditions. Based on his/her merit, and subject to vacancy position and other eligibility conditions, a candidate will be placed in the appropriate merit list (category and year). If a candidate's name is included in the merit list for a particular category for a particular year, his/her name will not be considered for inclusion in other list(s).

Accordingly, the final result of candidates selected in the Limited Departmental Competitive Examination (LDCE), held on 19.06.2026 through AIIMS, New Delhi, for the post of Assistant (Level 6 of Pay Matrix; Rs. 35,400-1,12,400) at ICMR Headquarters, for the vacancy year 2025 and 2026, is attached as **Annexure-A**.

5. The candidates have been selected in the order of merit, as per the vacancies and reservation points.
