OFFICE ORDER

Subject: Promotion to the post of Assistant through LDCE method for the vacancy year 2025 & 2026-Reg.

The undersigned is directed to say that against the vacancies reported to AIIMS, New Delhi for filling up the vacancies of Assistant in Level 6 of Pay Matrix (Rs. 35,400-1,12,400) under LDCE quota for the years 2025 and 2026 on the basis of the result of Limited Departmental Competitive Examination, ICMR declared the final results of LDCE 2025 and 2026 on 19.08.2026. 2. The promotion of above mentioned officials will be effective from the actual date of joining to the promotional post. Further, these officials are directed to give their acceptance for assumption of charge and join the duty to the post within 10 days from the date of receipt of this order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order shall automatically stand cancelled without waiting for any further notice. No extension of time for furnishing acceptance or

otherwise for joining the post on promotion will be entertained, except on compelling grounds.

3. They will be on probation for a period of two years in the post of Assistant, from the date of joining the post and they would be liable to serve anywhere in India.

4. Their pay will be fixed in terms of CCS (Revised Pay) Rules, 2016.

5. Promotees should give option within one month from the date of joining the post, whether they shall get their pay fixed in the new post either straightaway from the date of joining on promotion to the post of Assistant or from the date of their next increment in the previous Pay Level of 7th CPC Pay Matrix.

6. If they refuse to accept the promotion, they shall not be eligible to be considered for further financial up-gradation till they agree to be considered for promotion again.

7. In case of failure to report for duty on promotion within the stipulated period, they will be debarred from promotion for one year and no fresh offer of promotion will be given, during debarred period in terms of DoPT O.M No. 22034/3/81-Estt (D) dated 1st Oct 1981.

8. They will be governed by the usual terms and conditions of service under the Council.

9. Further, in terms of para 5 of DoPT's OM No. 36012/16/2019-Estt(Res.) dated 12.04.2022, the above promotions are also subject to further orders of the Hon'ble Supreme Court of India in the CA No. 629 of 2022 arising out of SLP (C) No. 30621/2011 titled Jarnail Singh & Ors. V. Lachhmi Narain Gupta and Ors. & other connected matters.
