1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

a. Bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrup t.

b. a bidder has no business or family relationship with any employee of ICMR,

c. Has your firm filed any lawsuits or requested arbitration with regard to any contract(s) within the last fiv e years.

d. Are there any judgements, claims, arbitration proceedings or suits pending or outstanding against your f irm or its officers? Bidder to upload undertaking to this effect with bid. Submit to ICMR- National Institute f or Research in Reproductive and Child Health office Mumbai on or before closing date of bid.

3. Complete Bid document duly signed and stamped on each page by the bidder in token of having unders tood and agreed to the terms and conditions mentioned.

SPECIAL ADDITIONAL TERMS AND CONDITIONS:

a. While applying for the Bidder document, the intending Bidder shall furnish proof of, experience certificat es, works completed/awarded, valid GSTIN as applicable and registration with Central/state Govt. departm ent and PSUs.

b. Intending bidders shall inspect and examine the Site and its surrounding and shall satisfy himself before submitting his Bidder as to the nature of the Site, the quantities and nature of works and material necessar y for the completion of the Works and the means of access to the Site, the accommodation he may require and in general shall himself obtain all necessary information as to risks, contingencies and other circumsta nces which may influence or affect this Bidder. The Certificate from site will be issued and bidder has to at tached that certificate as eligibility document for opening of financial bid. Failing of which the bidder is con sidered as not interested and not considered for opening of financial bid.

c. Rates for all items must cover the cost of all appropriate materials, all taxes including Service Tax/GSTIN , labour, machinery, scaffolding, tools and plants and all appliances including safety harnesses whatsoever necessary for the complete execution of the work.

d. The contractor will not be entitled for any compensation due to enactment of any law, regulation etc. on account whether the same is / are enforced by State / Central Govt. during the tenure of the contract, othe r than the Service Tax payable by the Service Receiver, as per the relevant Acts & Rules. Any other tax lik e Sales Tax on Works Contract, or levy, octroi, excise duty etc. on materials or any elements in respect of this contract, shall be payable by the contractor and ICMR- National Institute for Research in Reproductive and Child Health will not entertain any claims whatsoever in this respect.

e. It is mandatory that storage of all the hazardous chemicals /powders should be as per the directives of t he competent Government Authorities & should not be easily accessible to the persons other than the aut horized expert personnel of the contractor.

f. The workers carrying out the work will have to be provided with and shall wear proper safety masks, han d glows, shoes, and uniforms to identify & carry bags for materials. The tools to be used shall be of standa rd quality.

g. The premises shall always be kept clean & the company staff shall not be disturbed by the contractor's l abourers while working at site.

h. Price adjustment clause is not applicable to this contract. Mobilisation advance shall not be paid by ICM R- National Institute for Research in Reproductive and Child Health on any account.

i. Patent Office reserves to itself the right to accept or reject any Bidder either in part or in whole without a ssigning any reason for doing so & does not bind itself to accept the lowest or any Bidder.

j. The contractor shall adhere to the rules, regulations & instructions of Security Dept. of Patent Office secu rity at the office premises. The contractor should also ensure that the workers do not loiter anywhere in th e building other than the work site. Any action taken by Security Departments against the defaulters shall be contractor's responsibility.

k. If it is noticed that the unit rates quoted by the Bidderer for any items are unusually high or unusually lo w, it will be sufficient cause for rejection of the Bidder unless the Office is convinced about the reasonablen ess of the unit rates on scrutiny of the analysis for such unit rate to be furnished by the Bidderer on deman d.

I. Bidder are advised to submit the Bidder strictly based on the terms and conditions and specification cont ained in the Bidder Documents and not to stipulate any deviations. Conditional Bidders are liable to be reje cted.

m. Bidder submitted by Bidder shall remain valid for acceptance for a minimum period of 180 days from t he date of opening of the Bidders.

n. The rates quoted by bidder shall remain firm till completion of all works even during the extended perio d, if any, on any account what so ever. It is provided that the contractor shall not increase any of the rates, quoted in the Bidder till the completion of work.

o. The awarded repair work should be completed within the period indicates in the job order, if it is not completed within the time as specify in the order then penalty will be charged @1% of total cost of repair work.

p. In case any incident occurs with the deployed labour of the contractor/agency while working, will the res ponsibility of the contractor/agency. This office will not liable for any claiming.

q. During site inspection bidder found that other material required to make functional which was not includ ed in the scope of work, should be included in the quoted price. After award of contract vendor responsible for to completed the work.

Breach of Terms & Conditions:

In case of breach of any of terms and conditions mentioned above, the Competent Authority will have the ri ght to cancel the work order or contract as a whole without assigning any reason thereof, and nothing will be payable by the ICMR- National Institute for Research in Reproductive and Child Health in that event and the security deposit will be forfeited.

Subletting of Work:

The contract will be non transferable and hence the firm shall not be entitled to assign or sublet the work o r any part of it to any other person or party failing which the contract will be cancelled immediately.

Jurisdiction

The disputes, if any, arising between the successful applicant and ICMR- National Institute for Research in Reproductive and Child Health shall be resolved amicably, failing which shall be referred to an Arbitrator, mutually acceptable to both parties, appointed by the ICMR as per the Arbitration and Conciliation Act,199 6. Alternatively, this shall be subject to the exclusive jurisdiction of courts at Mumbai. Disclaimer: ICMR or any person authorized by the competent authority shall not be responsible for any omission or errors on th e part of Bidder.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
