If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. - (i) There is no requirement that the OEM of the Desktop computer systems should be a device partner of Microsoft and hold a Microsoft Authorization form

(ii) Microsoft OS may be sourced directly from Microsoft by the OEMs holding device partner status and those not holding device partner status may source from authorized distributors i.e., M/s. Ingram or M/s. Redington and their authorized channel partners.

(iii) Buyers may ensure that MAF shall not be made a mandatory requirement in bids.

(iv) If the supplies are made as per brands of OEMs who are global device partners, then the serial no of the machine supplied can be used to check the details of the product from the website of the OEM.

At the time of installation, if it is found that some minor additional hardware or software items are required to meet the operational requirement of the configuration but not included in the OEM's original list of deliverables, the OEM shall supply such items to ensure the completeness of the configuration at no extra cost.
- d. Bidders should submit only the necessary documentation related to this tender with a proper index highlighting the required technical specs in the product documentation that matches the tender specs or requested by the purchaser with page numbers. Failure to do the same will invalidate the bid and result in disqualification.
- e. The Bidder shall provide comprehensive onsite maintenance for hardware infrastructure, and active & passive components throughout the Agreement Period at no extra cost.
- f. Any hardware issues should be attended/resolved/rectified within 72 hours. It is the responsibility of Bidder to coordinate with the OEM to arrange for a replacement if required within the stipulated time period at no extra cost during the agreement period.
- g. Along with the technical bid, the OEM should submit a letter of commitment for 60 months (36 months)

hs of warranty and 24 months of comprehensive AMC) from the installation date, with respect to Hardware, Software, Firmware support.

- h. Bidder is requested to give undertaking Certificate regarding land border "I/ We have read the clause issued by Government of India regarding restrictions on procurement from a bidder of a country which shares a land border with India; I/ We certify that the bidder is not from such a country or, if from such a country, have been registered with the Competent Authority".
- i. In case of merger/sale of a business by the OEM, the above-said warranty, AMC and SLA will be applicable to the new OEM. In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such extensions of the insurance will still be done by the supplier, but the insurance extension charges at actual will be reimbursed.
- m. Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be insured in favor of ICMR-NIRRH, Parel, covering all risks basis for the goods from supplier/ manufacturer warehouse to consignee warehouse.
