Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

Service provider should admit and follow the following terms and conditions while providing the service.

1. The period of contract will be from 01/05/2025 to 31/03/2026.
2. The Annual Maintenance Contract (AMC) will be non-comprehensive type.
3. Annually, there will be two preventive maintenance visits and unlimited breakdown calls.
4. Annually, there will be one time calibration with NABL accredited equipment's.
5. The agency should provide standard Operating Procedure (SOP) for the work done during the Preventive Maintenance (PM) along with the AMC proposal.
6. PM visit will be pre-planned (half yearly) and completed within scheduled time period.
7. The emergency breakdown call should be addressed within 24 hours of reporting.
8. In case of breakdown, spares if required will be provided by ICMR-NIV Mumbai Unit; service provider will install the same for free of cost during their visit.
9. Service person must have valid official ID card during the visit. He should be well qualified and trained to solve the issues.
10. Service person will visit the institute with prior appointment, perform his task and submit the in detailed, properly written service report of the same before leaving the premises.

11. Service person must be vaccinated with Polio vaccine, Hepatitis vaccine and Measles rubella vaccine as a safety measure to work in the laboratory.
12. Service person will use Personal Protective Equipment (PPE) kit during the visit.
13. Mobile phones will not be allowed in the laboratory area.
14. Agency should submit the original copies of the invoice along with the service report for the payment.

Following points will be checked, verified and noted during the PM visit by service person:

Inspection of the installation area for-

1. Cleanliness
2. Dust free atmosphere
3. Temperature
4. Humidity
5. Air currents
6. Equipment is not exposed to sunlight
7. 5 to 20 cm free space on the sides and back of the equipment
8. A firm, levelled table capable of supporting the equipment is available
9. The electrical outlet feeding is not more than 1.5 m away from the equipment

1. Do Physical and electrical inspection.
2. Ensure that the area where the microscope is installed is protected from dust and humidity.
3. Ensure that the location of the microscope is far from water supplies
4. Verify and clean the optical alignment.
5. Verify the adjustment of the mechanical stage.
6. Confirm the adjustment of the specimen holder (gripping device).
7. Clean all the mechanical components.
8. Test the focus adjustment mechanism.
9. Verify the functioning of the diaphragm.
10. Lubricate the microscope according to the manufacturer's recommendations.
11. Verify that each component is in good condition, clean and mechanically well adjusted.
12. Verify the integrity of the connectors, fuses and of the incandescent light.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
