- 1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

- I. The bidder shall be a registered company in India under the relevant act(s) and should be in existence for a minimum period of Ten years as of the date of Submission of tender.
- II. Bidder should have valid ISO 9001:2008 and ISO 27001:2013 certification.
- III. Bidder must be empanelled with CERT-In and should have valid certification of empanelment.
- IV. The bidder should have an annual turnover of at least 20 Lakhs in any one of the last three preceding fi nancial years i.e. during FY 2021-22, 2022-23, 2023-24.
- V. The Bidder must upload a valid GST registration certificate & PAN Number of the firm allotted by the Income Tax authorities.
- VI. The Bidder should have performed at least three (03) Cyber Security Assessment projects in

the last five (05) financial years i.e. from 2019-20 to 2023-24 out of which one work order must be from an y of the Government / Public sector in India. Necessary documents asserting the same should be provided to the end users.

- VII. The information security expert working on this project should have minimum 5+ years of experience in conducting security audits.
- VIII. The Bidder shall not be blacklisted/defaulted by any Government agencies/ Utilities/Departments at the time of bidding.
- IX. The bidder should physically visit the site to understand the site working conditions, and nature of jobs prior to submission of tender and submit duly filled and signed. (allowable one week before the bid submis sion date of the tender and only on working hours/days)
- X. The Bidder should submit a Non-Disclosure Agreement and obtain the website/asset list for auditing fro m ICMR -NIMR during the site visit.
- XI. The bidder has to upload the "Bid annexures" enclose in this tender document duly filling in all details.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
