#### 4. Generic

- 7.Bidders may be asked to provide demonstration of the quoted model during the technical evaluation of b ids so as to ensure that quoted products are conformity with the quality and specifications as mentioned in bid document. Equipment which are not in conformity with the technical specifications shall be rejected. Bi dders shall bear the cost of demonstration and should be comply with the timelines of the Institute for demonstration of the product.
- 8.The firm should provide 1 year of warranty and three preventive maintenance visits per year and also breakdown visits as and when required during warranty period. When the equipment is u nder warranty/AMC, it would be the responsibility of the manufacturer/dealer/agent to procure spare parts and the Institute will not incur any expense on duty, octroi or handling charges, preventive maintenance, k its etc. The duration of warranty period will start after proper installation of the equipment and submitting users satisfactory report.
- 9.**Source of supply**: It shall be responsibility of seller to provide Documents regarding source of equipme nt such as copy of Performa invoice or any other documents to establish that the products supplied are ma nufactured by OEM indicated and sourced from them.
- **10.Spare Parts:** Seller shall provide materials, information etc. pertaining to spare parts manufactured a nd supplied by the OEM. It shall be ensured that the required spares are available for purchase at least for 10 years from date of installation. In case due to any reasons the production of the spare parts is discontinued sufficient advance notice should be given to the buyer/consignee before such discontinuation to provide adequate time to purchase the required spare parts etc. Further, OEM and their service centers /dealer s shall carry sufficient inventories to assure ex-stock supply of consumables and spares for the equipment so that the same are available. OEM or reseller shall always accord most favored client status to the buyer /consignee and shall give the most competitive price for spares of its machines/equipment supplied.
- 11. **Director, ICMR-NICPR, Noida** reserves the right to cancel the bid in part or full without assigning an y reason and liability on the buyer. On such cancellation the decision of the Director, ICMR-NICPR will be binding and final on the subject.
- **12. Installation, Training, Manuals**: Seller shall be responsible to carry out Installation & training of the equipment. They shall provide required jigs and tools for assembly, minor civil works for the completion of the installation and Training of Consignee/representatives for operating and maintaining the equipment and supplying operative & maintenance manual for the equipment.
- **13.Inspections and Tests:** Director, ICMR-NICPR or its representative shall have the right to inspect and/ or to test the Goods to confirm their conformity to the Contract specifications. Further, The Supplier may h ave an independent quality test conducted and the cost of such tests will be borne by the Supplier. Inspection of goods shall be carried out by representative of Director, ICMR-NICPR and they will issue an acceptance certificate.

- **14.Packing:** (a) The Supplier shall provide such packing of the Goods as is required to prevent their dama ge or deterioration during transit to their final destination, as indicated in the Contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temper atures, salt, and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods, final destination and the absence of heavy handling facilities at all points in transit (b) The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract, including additional requirements strictly as per Technical Specifications, and in any subsequent instructions ordered by the Procurement agency. (c) Packing and Marking shall be strictly as per Technical Specifications and will be inspected in terms of provisions of specifications before clearing for dispatch.
- **15.Payment:** 100% payment shall be made after receipt of complete goods/Equipment in good condition, acceptance and successful installation of goods/Equipment and subject to submission of Performance Bank Guarantee. This payment is subject to recoveries, if any, either on account of statutory deduction/ taxes/ Li quidated Damages, if any and non-rectification of defects/ deficiencies not attended by the Supplier or oth erwise. The firm is required to submit the following documents to Director, ICMR-NICPR for payment:
- (a) Copy of Purchase Order;
- (b) Copy of Extension Order (if any);
- (c) Invoice in original showing contract number, goods description, quantity, unit price and total a 8 / 12 m ount;
- (d) Installation Report in original duly signed and sealed by the authorized officer of the consignee;
- (e) Acknowledgement of Receipt of Goods issued by the consignee Institute/ Center;
- (f) Performance Bank Guarantee
- (g) Training to staff
- **16.Settlement of Disputes:** (a) If any dispute or difference of any kind whatsoever shall arise between t he Procurement agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- (b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual co nsultation, then either the Procurement agency or the Supplier may give notice to the other party of its int ention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given.
- (c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been gi ven in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced p rior to or after delivery of the Goods under the Contract. In the case of a dispute or difference arising betw een the Purchaser/Consignee and a domestic Supplier relating to any matter arising out of or connected wi th the contract, such dispute or difference shall be referred to the sol e arbitrator appointed by Director, IC MR-NICPR.
- (d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follo ws. (i) The venue of Arbitration shall be the place from where the contract is issued and the language of th e arbitration proceedings and that of all councils and communications between the parties shall be English. (ii) The decision of the majority of arbitrators shall be final and binding upon parties. (iii) Settlement of disp utes through pre-institution mediation and settlement in accordance with the commercial courts, commercial division and commercial appellate division of High Courts (Amendment) Act 2018, No. 28 of 2018 Chapt er IIIA.
- (e) Settlement of Disputes: Notwithstanding any reference to arbitration herein, a. the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and b. The Procurement agency shall pay the Supplier any monies due to the Supplier.
- 17. **Insurance:** Unless otherwise instructed, the supplier shall make arrangements for insuring the goods against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the following manner:
- (a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entire stores contracted for arrival in good condition at destination. The transit risk in this respect shall be cover ed by the Supplier by getting the stores duly insured. The insurance cover shall be obtained by the Supplie

r and should be valid till 3 months after the receipt of goods by the Consignee.

(b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the insurance will be got extended by the supplier at their cost till the successful installation, testing,

Commissioning and handing over of the goods to the consignee. In case the delay in the installation and co mmissioning is due to handing over of the site to the supplier by the consignee, such extensions of the insurance will still be done by the supplier, but the insurance extension charges at actual will be reimbursed.

- (c) Insurance would be borne by the Supplier: Insurance Certificate for 100% of the value to be insur ed in favour of Director, ICMR-NICPR, covering all risks basis for the goods from supplier/manufacturer war ehouse to consignee warehouse.
- 18. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time fra me(s) incorporated in the contract, the purchaser/consignee shall, without prejudice resort to other rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as I iquidity damages. Once the maximum deduction (10%) is reached purchaser may consider termination of the contract. Since the liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier.
- 19. GST will be applicable as per the latest GoI notification.
- 20. Delivery of Equipment means Supply, Installation, Testing and Commissioning of Equipment and training etc., if any.
- 21.Bidder is requested to give undertaking Certificate regarding land border "I/ We have read the clause is sued by Government of India regarding restrictions on procurement from a bidder of a country which shar es a land border with India; I/ We certify that the bidder is not from such a country or, if from such a country, have been registered with the Competent Authority"
- 22.Ministry of Finance Department of Expenditure Public Procurement Division Office Memorandum F.No. 6 /18/2019-PPD, dated 23<sup>rd</sup> July 2020 along with No.P-45021/2/2017-PP (Be-II)-Part(4)Vol.II, Ministry of Comm erce & Industry dated 19<sup>th</sup> July 2024 will be taken into consideration.
- 23.Bidders need to indicate the percentage of local content and the component wise bifurcation of the local content. Bidder has to inform the level of collaboration/joint venture etc. with the Indian firm with location of the office for manufacturing the goods in India as per Government of India Make in India (MII) norms/policy

#### 24.All software updates should be provided free of cost during warranty period.

- 25. AMC rates along with spare parts (for next 4 years) will be frozen before issuing purchase order.
- 26. Signed and stamped, compliance sheet meeting the product technical specifications may be submitted by the vendor.

# 27. The price of L1 will be inclusive of all the cost component i.e. basic cost of the equipment + 1 years of warranty + 4 years of AMC charges + GST.

- 28.Separate offer of AMC on main equipment for further 4 years after expiry of 1 year of warranty period s hould be included in the financial bid in the absence of which the offer is liable to be rejected. Payment of AMC shall be made only after the expiry of the warranty period of 1 year in case the buyer decides for avail ing AMC services. However, the buyer may decide not to enter into any AMC without assigning any reason which shall be binding upon the bidder.
- 29. The purchaser reserves its right to terminate the AMC contract at any time after giving due notice with out assigning any reason. The contractor will not be entitled to claim any compensation against such term ination. However, while terminating the contract, if any payment is due to the contractor for maintenance s ervices already performed in terms of the contract, these would be paid to it/him as per the contract terms
- 30. Bidder/OEM has given an undertaking that after expiry of warranty period, it will provide AMC service f or next 4 years for the offered product. Buyer reserves the right to enter into an AMC agreement (covering preventive maintenance and servicing) with the Successful Bidder / OEM after expiry of the Warranty perio d and the payment for the AMC charges would be made Annually after rendering of the AMC Services of the relevant AMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the AMC contract when called upon by the buyer. The original Performance Security of contract will be returned.

rned only after submission and verification of AMC Performance Security for 3% of total AMC value valid up to AMC period plus 2 months (if there is no other claim). (Undertaking of acceptance to be uploaded with b id)

- 31. The bidders should quote their lowest possible prices. The bidders shall be required to certify / give an undertaking to the effect that the rates quoted are minimum / reasonable and they have not quoted / char ged lower rates from any other Government / Autonomous organization / State / PSU Departments etc. (Kin dly attach copies of PO to certify the same).
- 32. The bidder must comply with the General Financial Rules 2017 and amendments issued by Governmen t of India.
- 33. The manufacturer's authorization should be taken on a tender specific basis, not general authorization/ dealership, and the same may be uploaded in the bid. In cases where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered.
