13. Generic

18. Warranty

Warranty period of the supplied products shall be 5 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. - 2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids/request for proposals document they will be suspended for the period of 1 year for bids/request for proposals document from being eligible to submit Bids/Proposals for contracts with ICMR.
- 3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.
- 4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.

- (a) Copy of Purchase Order;
- (b) Copy of Extension Order (if any);
- (c) Invoice in original showing contract number, goods description, quantity, unit price and total a mount
- (d) Installation Report in original duly signed and sealed by the authorized officer of the consigne e;

- (e) Acknowledgement of Receipt of Goods issued by the consignee Institute/ Center
- (f) Performance Bank Guarantee
- 9. Settlement of Disputes:- (a) If any dispute or difference of any kind whatsoever shall arise betw een the Procurement agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultati on.

- (i) The venue of Arbitration shall be the place from where the contract is issued and the language of the arbitration proceedings and that of all councils and communications between the parties sh all be English. - 16. The manufacturer's authorization must be insisted upon on a tender specific basis, not general authorization/'dealership, by so declaring in the bid documents clearly. In cases where the manufa cturer has submitted the bid, the bids of its authorized dealer will not be considered. In cases of a gents quoting in offshore procurements, on behalf of their principal manufacturers, one agent can not represent two manufacturers or quote on their behalf in a particular tender enquiry. One man ufacturer can also authorize only one agent/dealer.
