Scope of work:

- Effective treatment pest control against Mice, all type of Rats and Bandicoots towards rodent control.
- Controlling General insects, Pests, Rats, Cockroaches, Flies, Bed Bugs, Silver-fish, Spider, Ants, Carpet Beetle, House Cricket Lizard, Book Louse and all other small insects in all buildings at NIRT campus.
- Applying pesticides in all the manholes in NIRT premises.
- The pest control services must be undertaken once in a week on Friday afternoon. Cost of pesticides, materials and Chemicals required for pest control services during the contract period must be included within the quoted price for AMC.
- Cyanide killer should be provided as per requirement and 25 Nos. rat pads to be provided each month and dead rats to be removed simultaneously.
- The pest control spray is to be applied not only on the floors, furniture and fixtures but also on manholes and spot treatment remedies to ensure protection from all sorts of crawling pests.
