Design, Supply, Installation, Testing and Commissioning of Air cooling system at centralized equipment hall including following works.

1. The size of hall is 104 X 35 feet (3605 Sq.feet).
2. Air cooling system unit = 4 nos with capacity- 1.5 KW, 3 phase, 430 V AC, Air flow should be minim. – 25000 CMH.
3. Cooling system should be installed on Building terrace (Maintenance Bldg & Director office bldg) which is at both side of Hall with Heavy duty MS fabricated platform/stand and necessary supports etc.
4. Required ducting GI/PVC/FRP with Nut bolt and gasket suitable for cooling unit and to maintain the proper airflow from air cooling unit to hall centre.
5. Provision of aluminium embedded duct insulation.
6. The opening area of roof for laying the supply air flow should be sealed properly.
7. Provision of adjustable vertical & horizontal grills for ducting to maintain the proper air flow.

Note- 1. Required hall temperature is not more than 26 to 27 deg. Celsius and existing Temperature of hall is 38-41 deg. Celsius (in summer session).

3. Institute will be provide only Electrical power supply and water connection upto cooling units, any other works should be carry out by contractor.

2. Quotation must be submitted after site inspection to check the feasibility and proper design in discussion with Engineering division concerned Authority.
