2. 3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.

4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.

5. ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the DG, ICMR will be binding and final on the su bject.

In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such exten sions of the insurance will still be done by the supplier, but the insurance extension charges at act ual will be reimbursed.

(c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be ins ured in favour of Indian Council of Medical Research, covering all risks basis for the goods from su pplier/ manufacturer warehouse to consignee ware house

12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the t ime frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to othe r rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidity damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0. 5% per week of delay or part thereof until actual delivery or performance subject to a maximum o f 10% of the contract price.
