1. 2. 12. Generic

14. Turnover

18. Warranty

2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contr act, or to submit a performance security before the deadline defined in the request for bids/reques t for proposals document they will be suspended for the period of 1 year for bids/request for propo sals document from being eligible to submit Bids/Proposals for contracts with ICMR.

3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.

4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.

5. ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the DG, ICMR will be binding and final on the su bject.

6. Inspections and Tests: ICMR or its representative shall have the right to inspect and/or to test th e Goods to confirm their conformity to the Contract specifications . Further, The Supplier may have an independent quality test conducted and the cost of such tests will be borne by the Supplier.

b. Inspection of goods shall be carried out by representative of ICMR and they will issue an acceptance certificate.

7. Packing : (a) The Supplier shall provide such packing of the Goods as is required to prevent their damage o_deterioration during transit to their final destination, as indicated in the Contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and expo sure to extreme tempera tures, salt, and precipitation during transit and open storage. 8. Settlement of Disputes:- (a) If any dispute or difference of any kind whatsoever shall arise betw een the Procurement agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to resolve a micably such dispute or difference by mutual consultat ion.

(b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such m utual consultation, then either the Procurement agency or the Supplier may give notice to the othe r party of its intention to commence arbitration, as hereinafter provided, as to the matter in disput e, and no arbitration in respect of this matter may be commenced unless such notice is given.

(c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract. 11. Unless otherwise instructed, the supplier shall make arrangements for insuring the goods agai nst loss or damage incidental to manufacture or acquisition, transportation, storage and delivery i n the following manner:

a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entir e store contracted for arrival in good condition at destination. The transit risk in this respect shall be cove red by the Supplier by getting the stores duly insured. The insurance cover shall be obtain ed by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee.

(b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the i nsurance will be got extended by the supplier at their cost till the successful installation, testing, c ommissioning and handing over of the goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such exten sions of the insurance will still be done by the supplier, but the insurance extension charges at act ual will be reimbursed.

(c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be ins ured in favour of Indian Council of Medical Research, covering all risks basis for the goods from su pplier/ manufacturer warehouse to consignee ware house

12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the t ime frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to othe r rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidity damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0. 5% per week of delay or part thereof until actual delivery or performance subject to a maximum o f 10% of the contract price.
