Service details and Standards:

The level of service required is of the highest professional standard from the service provider (SP). Hiring f or this service would mean hiring for Pest control services only. Delivery services shall include, but not nec essarily be limited to the following:

- 1. Maintaining standards by using chemicals certified by only following bodies:
  - 1. WHOPES (World Health Organization Pesticide Evaluation Scheme)
  - 2. CIB (Central Insecticide board)

- 3. BIS (Bureau of Indian Standards)
- 2. Details of chemicals should contain Name of chemical, Name of company.
- 3. Concentration, Chemical composition, Quantity consumed, Size of packing, Batch no, Manufacturing & expiry date.
- 4. Service Provider should adhere to periodicity of spraying chemicals.
- 5. Inspection of quality by supervisors during the execution of service by the staff.
- 6. The service provider shall have all the necessary permits/ licenses/ clearances/certificates under the CIB & RC and other applicable laws for providing this service.
- 7. The supervisor and workers should be certified and should have valid license to perform such servic e.
- 8. The service provider must ensure that all necessary measures are taken to ensure safety of furnitur e, structure and people within the premise where the service is performed.
- 9. The service provider should deliver the service within stipulated time frame as agreed in the contra ct. The delay in execution of service may attract penalties. A mandatory, detailed contingency plan(s)/evacuation plan in the event of overdose of chemical shall be provided by the Service provider.

#### Warranty:

The service provider shall provide a warranty of minimum 1 year/12 months from the date of treatment for any relapse of pests/insect in the office premises, failing which conditions as given in Penalty clause shall a pply.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
