- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. Buyer Added Bid Specific SLA

Text Clause(s)

- 1. An office (registered/branch) of the service provider must be located in consignee location (Chennai). A copy of registration certificate should be submitted in this regard. In case of registered legal entity like a c ompany, society, LLP, Partnership etc. registration certificate issued by Registrar of Companies (ROC)/ Registrar of Firms must be submitted. In case of other legal entities, Labour Department Certificate issued by S tate Government or GST Registration certificate must be submitted.
- 2. The bidder must submit EPF and ESI contribution challans along with contribution statements for the last 6 months prior to bid start date. It should be uploaded in the Technical documents in GeM portal. The pay ment of EPF & ESI through challan must be made before due date for each month.
- 3. The Bidders offer is liable to be rejected if they don't upload any of certificates / documents sought in the bid document, ATC and corrigendum, if any
- 4. The Service provider must submit statutory certificates of registration for EPF, ESIC and GST in GeM Tec hnical specification documents.
- 5. The bidder should attach photographs of his registered office in consignee location along with name boa rd, valid rental agreement as on the date of contract and contact number to verify the details of the agenc y by the consignee.
- 6. The bidder must submit an undertaking for acceptance of terms and conditions of the bid document und er technical evaluation documents in GeM Portal.
- 7. Bidders must have annual turnover as per the bid document.
- 8. The bidder must submit PBG @ 3% of the contract value.
- 9. The Service provider must follow Minimum wage & VDA orders issued by Ministry of Labour & Employme nt from time to time. 10. Service Provider should verify all the credentials of the candidates before engage ment.
- 11. The staff will be deployed for NIRT, Chennai and its field units at Tiruvallur and Madurai. The staff are i nterchangeable between the field units on the basis of functional needs.
- 12. The Service Provider shall be solely responsible for maintaining the quality and level of service provide d. In case, the services are not found satisfactory at any time, the work order/tender is liable to be cancelle d.
- 13. Service Provider is required to pay salaries of contracted staff deployed first on their own on or before 5 th or in any case, not later than 7th of the next month and then claim payment from the institute by sub mitting bill along with all statutory documents like, PF, ESIC, GST etc. as well as Pay slip and bank stateme nt of payment done to staff. The Pay slip should clearly indicate the ESI number, UAN Number, Designation of the concerned staff, Number of working days and the salary breakup of employee clearly indicating Gros s Salary, Net Salary along with clear break up of PF, ESI contribution of both Employer and Employee. No o ther deductions should be made out of the salary of the employee.
- 14. The participating bidders should note that monthly bill will be passed for payment after duly following t he above mentioned procedures and no other extra deductions to be made from the wages payable to the staff.
- 15. EPF contribution is to be paid by the contractor up to the maximum wage ceiling of Rs.15,000/-. The C ontribution of EPF/ESI should be made as per rules by the contractor.
- 16. GST and service charges will be paid separately to the service provider as per contract.
- 17. The monthly wages of the manpower should be made based on the number of days worked.

- 18. No person shall leave the assigned position, without prior approval of his/her Reporting Authority/ Head of Institute.
- 19. The service provider should provide uniform and ID card to the staff.
- 20. In the event of leave without prior permission of Reporting Authority and/or any willful unauthorized ab sence, the concerned candidate holding the position will not be permitted to resume duty without prior per mission of Head of the Institute.
- 21. The Service provider should provide staff immediately in case of absence of any of the staff engaged.
- 22. Service Provider will be responsible for any administrative issues of the candidate and not the institute
- 23. The incumbents selected will have no claim for regular appointments under ICMR-NIRT or continuation of his/her services in any other contract.
- 24. Agencies or appointed contractors may visit ICMR-NIRT, Chennai on any working day between 02:00 P M and 03:00 PM to understand the scope / nature of work.
- 25. Any dispute arising out of the terms of this contract or the interpretation of any clause herein shall be s ettled by mutual discussion between the ICMR-NIRT and agency / contractor. In case of any disputes, the j urisdiction will be ICMR-NIRT, Chennai.
- 26. No payment shall be made in advance nor any loan from any bank or financial institution recommende d on the basis of the contract order awarded to the agency.
- 27. Candidate must know regional language of the place of posting.
- 28. The engagement is purely on contract basis and the Director of the Institute reserves the right to dispense with the services of the candidate at any time without assigning any reason.
- 29. The engagement will get automatically cease on the end date of contract.
- 30. On termination of the contract, the staff shall not be entitled to any terminal benefits.
- 31. The staff will not be provided medical facility under CGHS / CS (MA) Rules as admissible to regular em ployees.
- 32. No service/experience certificates will be issued by the institute to the staff.
- 33. The contract will be awarded initially for a period of one year and based on the satisfactory services, it can be extended for a further period as per the decision of the Competent Authority. All the rights to exten d or reduce the period of contract or termination of the contract will be at the discretion/jurisdiction of the Director, ICMR-NIRT, Chennai and will be binding on the agency.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
