- c) **ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer.** On such cancellation the decision of the DG, ICMR will be binding and final on the subject.

- f) Prices shall be quoted in Indian Rupees only.
- g) Signed / E-sign & scanned quotes through email are acceptable.
- h) **Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.
