Interested service agencies having experience in the relevant field either local based or has its service unit at Chennai should submit their lowest competitive rates along with company/ profile and experience documents.

The quotation superscripted as “CAMC for 10KVA EMERSON UPS at NIRT Campus” addressed to “The Director, ICMR - National Institute for Research in Tuberculosis, No.1, Mayor Sathyamoorthy Road, Chetpet, Chennai - 31” should reach this office latest by 10.02.2026 till 03:00 P.M. The same may either be dropped at the tender box available at NIRT Stores or sent through Speed Post / Courier or by E-mail to nirtdirector@icmr.gov.in with signature & seal in company letter head latest by 10th February 2026 by 03.00 PM.

Mode of Service:

1. Preventive Maintenance should be done once in 2 months without fail.
2. Call should be attended within 2 Hours on – site response.
3. If the call is not completed within 24 Hours, a replacement /stand-by should be provided.
4. The firm should preferably have experience in maintenance of similar setup.
5. Preference will be given to those firms who are registered /approved by any competent Government Department /Organization.
6. Replacement of Faulty items has to be of same model, brand and capacity. Otherwise, if the items are not available with manufacturer or agency, it may be replaced with other equivalent make.
7. Comprehensive AMC should cover all the spares, wear and tear items.



8. The firm should inspect the Battery Strength once in two months and report to ICMR-NIRT. Batteries will be supplied by ICMR-NIRT and necessary replacement work has to be carried out by the agency on their own.
9. All the configuration may be inspected and sticker may be pasted at the time of AMC

Terms & Conditions:

1. The NIRT Office reserves the right to accept or reject any or all contract without assigning any reasons thereof.
2. Any decision taken by the Director, NIRT at any point of time in connection with this process shall be final and conclusive and no claim or dispute from any quarter in that regard shall be entertained.
3. The bidders should do site inspection of the location to understand the scope of work at ICMR-NIRT, Chennai before submission of the quotation and the inspection report should be duly signed by the Electrical team of NIRT.
4. No advance payment will be made before executing the Contract. The payment will be made upon rendering the services in two instalments, one on completion of the first half of the service period and the other on completion of one year after receipt of satisfactory report from end user concerned.
5. NIRT, Chennai will not be responsible for any delay or late receipt of quotations and the same will not be considered under any circumstances.
6. No extra payment will be made on account of transportation, handling, loading, unloading, labour charges etc.,
7. While submitting the quotations the rate against each work and net amount to be paid, GST etc. should be specified separately.
8. The bidders must submit GST Certificate and site inspection report along with the quotation.
