General Terms and conditions for Non-Comprehensive of Annual Maintenance Contract

1. This is a tender enquiry and must not be treated as an order.
2. The period of Contract under the scope of work shall be normally for a period of one year from the date of signing contract and commencement of services. This period may be extended / curtailed without assigning any reason or giving prior notice.
3. The rate quoted shall be valid for a period of one year from the date of signing the contract.
4. In case of breach of any terms and conditions, the Competent Authority will have the right to accept or reject any or all applicants without assigning any reasons.
5. Any decision taken by the Competent Authority, NIV at any point of time in connections with this process shall be final and conclusive and no claim or dispute from any quarter in that regard shall be entertained.
6. Requirement of AMC service quantity will either increase or decrease. Final requirement will be mentioned in the purchase order issued to the firm.
7. **Validity of the quotation:** Minimum 90days validity from the date of quote to be provided.
8. **Eligibility:** The Bidder must be a Manufacturer or its authorized Agent.
9. **One Bid per Bidder:** A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or,

as a member of a joint venture, more than one bid will cause all the proposals with the firm's participation to be disqualified.

11. The prices shall be quoted in Indian Rupees only.

The site visit shall be cleared only after verifying the credentials of the vendor. The quotations submitted without documentary evidences of experience will not be considered.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
